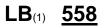

LB 558 appropriates \$10,269,035 of general funds in FY2019-20 and \$10,269,035 of General Funds in FY2020-21 to the Department of Health and Human Services for Program 424 – Developmental Disability Aid. The aid increase is to be used for an increase in rates paid to providers of developmental disability services.

The increase in general funds will be matched by federal Medicaid funds. Approximately \$12.1 million of increased federal funds will be received for rate increases in FY20 and FY21, if the general funds are appropriated.
