The University of Nebraska does not anticipate any material cost increases with LB 1137.

However, as the University disclosed in the original LB 962 (2020 session) fiscal note, additional contract attorneys will be required to review contract provisions under the Student-Athlete Name, Image, Likeness Rights Act. This legal support does not currently exist within the University's Legal Counsel office or the athletics departments at UNL, UNO or UNK. The estimated fiscal impact is \$310,000 per year (two attorneys at \$120,000 plus benefits).
