**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB 1146 amends the Interlocal Cooperation Act to include language so only members of the governing bodies of the public agencies party to an agreement shall comprise the membership of any separate legal or administrative agency.

Section 2 requires eligible voters of the public agencies to approve the proposed creation for joint entities prior to creation of the joint entities.

Section 3 prohibits joint entities to issue bonds under section 13-808 for any building or infrastructure project proposed by such joint entity until the project is approved by the eligible voters of the public agencies comprising the joint entity.
