LB738 amends the definition of bicycle to include electric bicycles. In addition, the bill establishes Class I, Class II, and Class III electric bicycles classes based on different types of bicycle propulsion and levels of speed.

Both the Nebraska Department of Motor Vehicles (NDMV) and the Nebraska Department of Transportation (NDOT) have all indicated no fiscal impact from LB738.

We agree with no fiscal impact to NDMV nor NDOT.
