Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 979 mandates the Nebraska Department of Correctional Services (NDCS), Office of Probation Administration, and Division of Parole Supervision to annually report on active cases. This report, due on or before November 1<sup>st</sup> of each year, must include demographic details, citizenship status, offense details, and sentence specifics of each case, excluding personal identifying information.

The Supreme Court states that the requirement from LB 979 to establish citizenship status could have a significant impact on the Probation system. Currently, there is no legal obligation to verify an individual's citizenship status. Implementing this requirement would lead to significant operational changes. Primarily, it would necessitate additional staff time across Probation offices nationwide to gather, verify, and maintain each probationer's citizenship documentation using Federal systems. Furthermore, the Federal system for verifying immigration status incurs fees for each individual checked. As of now, the Judicial Branch does not have an estimate of this cost.

NDCS and the Board of Parole estimate no fiscal impact.
