This bill will adopt the Nebraska Behavioral Health Jail Diversion Planning and Coordination Advisory Council Act.

This council will be within the Department of Health and Human Services (HHS) for administrative and budget support. Members of the council are to be reimbursed for their expenses. Using information from HHS, the following table illustrates the estimated cost of implementing this bill:

The Legislative Fiscal Office analyst (LFO) arrived at a slightly different amount then HHS (\$45,892).

There should not be a fiscal impact to the other state agencies that are on this council since HHS is responsible for reimbursing expenses.

The Nebraska Commission on Law Enforcement and Criminal Justice (Crime Commission) notes that section 8 of the bill requires the uniform crime data analysis system to include admissions to and discharges from the behavioral health jail diversion programs. The Crime Commission notes that they may need to hire an additional FTE at \$45,000 per year (\$37,000 salary + \$8,000 benefits) if their current staff cannot handle this additional duty imposed by this section of the bill. The costs for this additional FTE, if needed, would be paid from the Uniform Data Cash Fund.
