# Governor names economic priorities

new perspectives to the challenges facing Nebraska, Gov. Dave Heineman delivered his State of the State address to lawmakers Jan. 15.

The governor noted that the 101st Legislature is the first since the full implementation of term limits.

"We have begun a new chapter in Nebraska history," Heineman said. "You bring a new vitality, new enthusiasm and new ideas to the Nebraska Legislature."

The most important challenge law-

rging new senators to bring makers face is the economy, according to the governor. While Nebraska is one of a only a few states not facing a financial crisis, citizens still need to brace for tough economic times ahead, Heineman said.

"The next few years will present one of the greatest financial challenges of our lifetime," he said.

The governor commended the Legislature for making difficult budget decisions in the past that will lessen the impact of an uncertain economic future. Nebraska has modernized economic incentives, lowered taxes, controlled spending, created jobs and invested well, he said.

Heineman cited passage of the Nebraska Advantage program in 2005 as a model economic program. Since its inception, 185 companies have located or expanded in Nebraska, he said. "These companies are expected to invest more than \$5.3 billion in our economy and create more than 15,000 new jobs."

But, the governor said, more needs to be done. Heineman said his budget recommendations for the upcoming biennium are crucial to the state's continued economic success.

He said avoiding tax increases is his first priority.

"Nebraska is still a high tax state," Heineman said. "Nebraskans need tax relief."

Of particular importance, he said, will be funding the \$230 million property tax program established two years ago. Increasing property taxes in an economic downturn would be unacceptable, he said.

Second, the governor stressed the importance of prioritizing education. "Education is the great equalizer," Heineman said. "And a quality education is essential for our children to compete."

The governor's budget recommendations include increased funding for state aid to education, special education, the University of Nebraska and state and community colleges.

Despite the difficult economic climate, Heineman named continued funding for programs that aid Nebraska's vulnerable populations as his third priority.

The state Department of Health and Human Services will spend more than \$1.2 billion annually in the coming biennium to address the needs of children and families in distress, the mentally ill, veterans and those with substance abuse problems, Heineman said.

The governor acknowledged gaps in access to these programs and said he looks forward to working with the Legislature on those issues. Some of those gaps were highlighted last year by the state's safe haven law and by inquiries into problems at the Beatrice State Developmental Center.

While encouraging spending on education and programs for vulnerable Nebraskans, the governor also stressed the need to maintain a strong cash reserve.

"The cash reserve is our rainy day fund," Heineman said, "but we need to be mindful that it is only beginning to rain."

He pointed out several potential drains on the reserve, including potential water litigation, possible loss of federal funding for the Beatrice State Developmental Center and state pension losses due to stock market declines.

Yet, the governor remained optimistic that Nebraska will fare well in the difficult days ahead.

"Our hard work has better positioned us to weather

the coming fiscal storm," he said. "I have confidence in our ability to build an even brighter future in the years ahead."


