- 1 A BILL FOR AN ACT relating to appropriations; to amend section 55-801,
- 2 Reissue Revised Statutes of Nebraska, and section 84-612, Revised
- 3 Statutes Supplement, 2021; to rename and change provisions relating
- 4 to the United States Space Command Headquarters Assistance Fund; to
- 5 change a transfer from the Cash Reserve Fund; to state intent to
- 6 appropriate funds to the Commission on Military and Veteran Affairs;
- 7 to repeal the original sections; and to declare an emergency.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 55-801, Reissue Revised Statutes of Nebraska, is
2 amended to read:

3 55-801 The Military Base Development ~~United States Space Command~~
4 ~~Headquarters Assistance~~ Fund is created. The fund shall be used to
5 contribute to the construction or development of any military base in the
6 state of the United States Space Command headquarters if the State of
7 ~~Nebraska is selected as the site for the headquarters.~~ The Adjutant
8 General of the State of Nebraska shall administer the fund. The fund
9 shall consist of transfers authorized by the Legislature and any gifts,
10 grants, or bequests from any source, including federal, state, public,
11 and private sources, for such purposes. Any money in the fund available
12 for investment shall be invested by the state investment officer pursuant
13 to the Nebraska Capital Expansion Act and the Nebraska State Funds
14 Investment Act.

15 Sec. 2. Section 84-612, Revised Statutes Supplement, 2021, is
16 amended to read:

17 84-612 (1) There is hereby created within the state treasury a fund
18 known as the Cash Reserve Fund which shall be under the direction of the
19 State Treasurer. The fund shall only be used pursuant to this section.

20 (2) The State Treasurer shall transfer funds from the Cash Reserve
21 Fund to the General Fund upon certification by the Director of
22 Administrative Services that the current cash balance in the General Fund
23 is inadequate to meet current obligations. Such certification shall
24 include the dollar amount to be transferred. Any transfers made pursuant
25 to this subsection shall be reversed upon notification by the Director of
26 Administrative Services that sufficient funds are available.

27 (3) In addition to receiving transfers from other funds, the Cash
28 Reserve Fund shall receive federal funds received by the State of
29 Nebraska for undesignated general government purposes, federal revenue
30 sharing, or general fiscal relief of the state.

31 (4) The State Treasurer shall transfer fifty-four million seven

2 (g) Deterrence Park;

3 (h) Looking Glass Heritage Park;

4 (i) Quarters 13 comprehensive repairs, design, and construction; and

5 (j) B1000 Rooftop Garden.

6 (2) It is the intent of the Legislature that the development
7 described in subsection (1) of this section be funded with funds that
8 were set aside for the United States Space Command headquarters since the
9 State of Nebraska was not selected as the site for the headquarters.

10 Sec. 4. Original section 55-801, Reissue Revised Statutes of
11 Nebraska, and section 84-612, Revised Statutes Supplement, 2021, are
12 repealed.

13 Sec. 5. Since an emergency exists, this act takes effect when
14 passed and approved according to law.
