- 1 A BILL FOR AN ACT relating to teachers and administrators; to amend 2 section 79-809, Reissue Revised Statutes of Nebraska, sections
- 3 79-807 and 79-808, Revised Statutes Cumulative Supplement, 2020, and
- 4 section 79-8,145, Revised Statutes Supplement, 2021; to remove basic
- 5 skill and content test requirements; to harmonize provisions; and to
- 6 repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 79-807, Revised Statutes Cumulative Supplement,
- 2 2020, is amended to read:
- 3 79-807 For purposes of sections 79-806 to 79-815, unless the context
- 4 otherwise requires:
- 5 (1) Basic skills competency means either (a) proficiency in (i) the
- 6 written use of the English language, (ii) reading, comprehending, and
- 7 interpreting professional writing and other written materials, and (iii)
- 8 working with fundamental mathematical computations as demonstrated by
- 9 successful completion of an examination designated by the board or (b)
- 10 successful employment experiences;
- 11 (1) (2) Board means the State Board of Education;
- 12 (2) (3) Certificate means an authorization issued by the
- 13 commissioner to an individual who meets the qualifications to engage in
- 14 teaching, providing special services, or administering in prekindergarten
- 15 through grade twelve in the elementary and secondary schools in this
- 16 state;
- 17 (3) (4) Commissioner means the Commissioner of Education;
- 18 (4) (5) Department means the State Department of Education;
- 19 <u>(5) (6)</u> Human relations training means course work or employment
- 20 experiences that lead to (a) an awareness and understanding of the
- 21 values, lifestyles, contributions, and history of a pluralistic society,
- 22 (b) the ability to recognize and deal with dehumanizing biases,
- 23 including, but not limited to, sexism, racism, prejudice, and
- 24 discrimination, and an awareness of the impact such biases have on
- 25 interpersonal relations, (c) the ability to translate knowledge of human
- 26 relations into attitudes, skills, and techniques which result in
- 27 favorable experiences for students, (d) the ability to recognize the ways
- 28 in which dehumanizing biases may be reflected in instructional materials,
- 29 (e) respect for human dignity and individual rights, and (f) the ability
- 30 to relate effectively to other individuals and to groups in a pluralistic
- 31 society other than the applicant's own;

- 1 (6) (7) Special education training means course work or employment
- 2 experiences that provide an individual with the knowledge of (a) the
- 3 exceptional needs of the disabilities defined under the Special Education
- 4 Act, (b) the major characteristics of each disability in order to
- 5 recognize its existence in children, (c) the various alternatives for
- 6 providing the least restrictive environment for children with
- 7 disabilities, (d) methods of teaching children with disabilities in the
- 8 regular classroom, and (e) prereferral alternatives, referral systems,
- 9 multidisciplinary team responsibilities, the individualized education
- 10 program plan process, and the placement process;
- 11 (7) (8) Special services means supportive services provided to
- 12 students that do not primarily involve teaching, including, but not
- 13 limited to, (a) audiology, psychology, and physical or occupational
- 14 therapy, (b) the coaching of extracurricular activities, and (c) subject
- 15 areas for which endorsement programs are not offered by a standard
- 16 institution of higher education; and
- 17 <u>(8)</u> Standard institution of higher education means any college
- 18 or university, the teacher education programs of which are fully approved
- 19 by the board or approved in another state pursuant to standards which are
- 20 comparable and equivalent to those set by the board.
- 21 Sec. 2. Section 79-808, Revised Statutes Cumulative Supplement,
- 22 2020, is amended to read:
- 79-808 (1) The board shall establish, adopt, and promulgate
- 24 appropriate rules, regulations, and procedures governing the issuance,
- 25 renewal, conversion, suspension, and revocation of certificates and
- 26 permits to teach, provide special services, and administer based upon (a)
- 27 earned college credit in humanities, social and natural sciences,
- 28 mathematics, or career and technical education, (b) earned college
- 29 credit, or its equivalent in professional education, for particular
- 30 teaching, special services, or administrative assignments, (c) criminal
- 31 history record information if the applicant has not been a continuous

- 1 Nebraska resident for five years immediately preceding application for
- 2 the first issuance of a certificate, (d) human relations training, (e)
- 3 successful teaching, administration, or provision of special services,
- 4 and (f) moral, mental, and physical fitness for teaching, all in
- 5 accordance with sound educational practices. Such rules, regulations, and
- 6 procedures shall also provide for endorsement requirements to indicate
- 7 areas of specialization on such certificates and permits. Such rules and
- 8 regulations shall not require any test of basic skills or content
- 9 knowledge.
- 10 (2) The board may issue a temporary certificate, valid for a period
- 11 not to exceed two years, to any applicant for certification who has not
- 12 completed the human relations training requirement.
- 13 (3) Members of any advisory committee established by the board to
- 14 assist the board in teacher education and certification matters shall be
- 15 reimbursed for expenses as provided in sections 81-1174 to 81-1177. Each
- 16 school district which has an employee who serves as a member of such
- 17 committee and which is required to hire a person to replace such member
- 18 during the member's attendance at meetings or activities of the committee
- 19 or any subcommittee thereof shall be reimbursed from the Certification
- 20 Fund for the expense it incurs from hiring a replacement. School
- 21 districts may excuse employees who serve on such advisory committees from
- 22 certain duties which conflict with any advisory committee duties.

- 24 amended to read:
- 25 79-809 In addition to the requirements in section 79-808, the
- 26 maximum which the board may require for the issuance of any entry-level
- 27 certificate or permit shall be that the applicant (1) has a baccalaureate
- 28 degree that qualifies for a certificate to teach, (2) has satisfactorily
- 29 completed, within two years of the date of application, an approved
- 30 program at a standard institution of higher education, (3) has
- 31 satisfactorily demonstrated basic skills competency, (4) has special

- 1 education training, (4) (5) has earned college credit in an approved
- 2 program, at a standard institution of higher education, for which
- 3 endorsement is sought, and (5) (6) has paid a nonrefundable fee to the
- 4 department as provided in section 79-810.

- 6 amended to read:
- 7 79-8,145 (1) In addition to certificates issued pursuant to sections
- 8 79-806 to 79-815:
- 9 (a) The Commissioner of Education shall, subject to the provisions
- 10 of subsection (3) of this section, grant a temporary certificate to teach
- on a full-time basis to any applicant who:
- 12 (i) Has completed a teacher education program at a standard
- institution of higher education as defined in section 79-807; and
- (ii) Currently possesses a certificate to teach in good standing
- 15 from another state; and
- 16 (b) The commissioner may, subject to the provisions of subsection
- 17 (3) of this section, grant a temporary certificate to teach on a full-
- 18 time basis to any applicant who has :(i) Has earned and been awarded a
- 19 bachelor's degree, graduate degree, or professional degree from a college
- 20 or university accredited by an accrediting organization recognized by the
- 21 United States Department of Education. ; and
- 22 (ii) Has satisfactorily demonstrated basic skills competency and
- 23 passed any appropriate subject area examination as designated by the
- 24 State Board of Education.
- 25 (2) Any temporary certificate to teach issued pursuant to this
- 26 section shall be valid for a period not to exceed two years, during which
- 27 the holder of such temporary certificate must obtain a certificate to
- 28 teach pursuant to sections 79-806 to 79-815 by completing the
- 29 requirements contained in such sections.

- 31 section shall be subject to a criminal history record information check
