5 24-201.01 ~~On July 1, 2020, the salary of the Chief Justice and the~~
6 ~~judges of the Supreme Court shall be one hundred eighty-seven thousand~~
7 ~~thirty-six dollars and one cent. On July 1, 2021, the salary of the Chief~~
8 ~~Justice and the judges of the Supreme Court shall be one hundred ninety-~~
9 ~~two thousand six hundred forty-seven dollars and nine cents. On July 1,~~
10 ~~2022, the salary of the Chief Justice and the judges of the Supreme Court~~
11 ~~shall be one hundred ninety-eight thousand four hundred twenty-six~~

19 other public office of profit or trust during their terms of office nor
20 accept any public appointment or employment under the authority of the
21 government of the United States for which they receive compensation for
22 their services. Such salaries shall be payable in equal monthly
23 installments.

19 perform the duties devolving upon him or her by law, and be subject to
20 the orders of the court. The Clerk of the Supreme Court shall receive an
21 annual salary to be fixed by the Supreme Court.

23 shall keep his or her office at the State Capitol, perform the duties

5 District No. 2 shall contain the counties of Sarpy, Cass, and Otoe;

6 District No. 3 shall contain the county of Lancaster;

7 District No. 4 shall contain the county of Douglas;

8 District No. 5 shall contain the counties of Merrick, Platte,
9 Colfax, Boone, Nance, Hamilton, Polk, York, Butler, Seward, and Saunders;

10 District No. 6 shall contain the counties of Dixon, Dakota, Cedar,
11 Burt, Thurston, Dodge, and Washington;

12 District No. 7 shall contain the counties of Knox, Cuming, Antelope,
13 Pierce, Wayne, Madison, and Stanton;

16 Greeley, Sherman, and Howard;

23 well-being of the state, and (3) suitable laws should be enacted for the
24 establishing and for the preservation of such an administration of the
25 Nebraska Workers' Compensation Act, there is hereby created, pursuant to
26 the provisions of Article V, section 1, of the Nebraska Constitution, a
27 court, consisting of ~~seven~~ judges, to be selected or retained in office

1 other states; five copies to the State Library to keep for daily use; not
2 to exceed twenty-five copies to the Legislative Council for bill drafting
3 and related services to the Legislature and executive state officers; as

31 (1) To consult with and assist the Legislative Council prior to each

1 regular session of the Legislature in the preparation of the report of
2 the Legislative Council as to defects in the Constitution of Nebraska and
3 laws of Nebraska and to draft in the form of bills proposed legislation
4 to carry out the recommendations contained in the report;

5 (2) To prepare for submission to the Legislature, from time to time,
6 when recommended by the Legislative Council in its report as to defects
7 in the Constitution of Nebraska and laws of Nebraska, a rewriting and
8 revision, chapter by chapter, in simplified style and phraseology, of the

4 operative three calendar months after the adjournment of this legislative
5 session. The other sections of this act become operative on their
