- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 243, One Hundred
- 3 Eighth Legislature, First Session, 2023; and to declare an
- 4 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$294,833 from the
2 General Fund for FY2023-24 and (2) \$131,577 from the General Fund for
3 FY2024-25 to the State Department of Education, for Program 25, to aid in
4 carrying out the provisions of Legislative Bill 243, One Hundred Eighth
5 Legislature, First Session, 2023.

6 Total expenditures for permanent and temporary salaries and per
7 diems from funds appropriated in this section shall not exceed \$68,310
8 for FY2023-24 or \$72,409 for FY2024-25.

9 Sec. 2. There is hereby appropriated (1) \$-0- from the Community
10 College Future Fund for FY2023-24 and (2) \$246,499,886 from the Community
11 College Future Fund for FY2024-25 to Agency 83, Aid to Community
12 Colleges, for Program 152, to aid in carrying out the provisions of
13 Legislative Bill 243, One Hundred Eighth Legislature, First Session,
14 2023.

15 There is included in the appropriation to this program for FY2023-24
16 \$-0- Cash Funds for state aid, which shall only be used for such purpose.
17 There is included in the appropriation to this program for FY2024-25
18 \$246,499,886 Cash Funds for state aid, which shall only be used for such
19 purpose.

20 No expenditures for permanent and temporary salaries and per diems
21 for state employees shall be made from funds appropriated in this
22 section.

23 Sec. 3. There is hereby appropriated (1) \$409,719 from the General
24 Fund for FY2023-24 and (2) \$439,128 from the General Fund for FY2024-25
25 to the Tax Equalization and Review Commission, for Program 115, to aid in
26 carrying out the provisions of Legislative Bill 243, One Hundred Eighth
27 Legislature, First Session, 2023.

28 Total expenditures for permanent and temporary salaries and per
29 diems from funds appropriated in this section shall not exceed \$334,133
30 for FY2023-24 or \$358,804 for FY2024-25.

31 Sec. 4. Since an emergency exists, this act takes effect when

1 passed and approved according to law.
