- 1 A BILL FOR AN ACT relating to government; to amend sections 32-308, 32-309, 32-914, 32-941, 32-942, 32-943, 60-484.02, and 71-612, 2 3 Reissue Revised Statutes of Nebraska, and sections 32-101, 32-103, 4 32-202, 32-304, 32-947, and 60-4,115, Revised Statutes Cumulative Supplement, 2022; to require valid photographic identification for 5 6 voting purposes; to change provisions relating to elections and 7 confidential information; to eliminate the fee for certain state 8 identification cards and certified copies of birth certificates; to 9 harmonize provisions; to provide operative dates; to repeal the original sections; and to declare an emergency. 10

- 25 under section 85-2902, or a Native American Indian tribe or band
- 26 <u>recognized by the United States Government that:</u>
- 27 (a) Shows the name of the individual to whom the document was issued
- 28 and the name conforms to the name in the individual's voter registration
- 29 <u>record;</u>
- 30 (b) Shows a photograph or digital image of the individual to whom
- 31 the document was issued; and

- 2 indefinite expiration date; or
- 3 (3) A document that satisfies all of the following:

- 7 (b) The document shows a digital image of an affidavit signed by the
- 8 individual to whom the document was issued stating that the individual
- 9 has a religious objection to being photographed as provided in section 16

- 13 <u>(d) The document has no expiration date or states that the document</u>

- 7 32-304 (1) The Secretary of State in conjunction with the Department

- 9 which may be used statewide to register to vote, and update voter
- 10 registration records, and verify voter identification electronically
- 11 using the Secretary of State's website. An applicant who has a valid
- 12 Nebraska motor vehicle operator's license or state identification card
- 13 may use the application process to register to vote or to update his or
- 14 her voter registration record with changes in his or her personal
- 15 information or other information related to his or her eligibility to
- 16 vote. For each electronic application, the Secretary of State shall
- 17 obtain a copy of the electronic representation of the applicant's digital
- 18 <u>image and</u> signature from the Department of Motor Vehicles' records of his
- 19 or her motor vehicle operator's license or state identification card for
- 20 purposes of voter registration, and electronic poll books, and verify
- 21 <u>voter identification</u>.
- 22 (2) The application shall contain substantially all the information
- 23 provided in section 32-312 and the following informational statements:
- 24 (a) An applicant who submits this application electronically is
- 25 affirming that the information in the application is true. Any applicant
- 26 who submits this application electronically knowing that any of the
- 27 information in the application is false shall be guilty of a Class IV
- 28 felony under section 32-1502 of the statutes of Nebraska. The penalty for
- 29 a Class IV felony is up to two years imprisonment and twelve months post-
- 30 release supervision, a fine of up to ten thousand dollars, or both;
- 31 (b) An applicant who submits this application electronically is

- 1 agreeing to the use of his or her digital signature from the Department
- 2 of Motor Vehicles' records of his or her motor vehicle operator's license
- 3 or state identification card for purposes of voter registration and
- 4 verification of voter identification;
- 5 (c) To vote at the polling place on election day, the completed
- 6 application must be submitted on or before the third Friday before the
- 7 election and prior to midnight on such Friday; and
- 8 (d) The election commissioner or county clerk will, upon receipt of
- 9 the application for registration, send an acknowledgment of registration
- 10 to the applicant indicating whether the application is proper or not.
- 11 Sec. 6. Section 32-308, Reissue Revised Statutes of Nebraska, is
- 12 amended to read:
- 13 32-308 (1) The Secretary of State and the Director of Motor Vehicles
- 14 shall enter into an agreement to match information in the computerized
- 15 statewide voter registration list with information in the database of the
- 16 Department of Motor Vehicles to the extent required to enable each such
- 17 official to verify the accuracy of the information provided on
- 18 applications for voter registration and to verify voter identification.
- 19 The Director of Motor Vehicles shall enter into an agreement with the
- 20 Commissioner of Social Security under section 205(r)(8) of the federal
- 21 Social Security Act, 42 U.S.C. 405(r)(8), as such section existed on
- 22 April 17, 2003, for purposes of the Election Act.
- 23 (2) The Department of Motor Vehicles, with the assistance of the
- 24 Secretary of State, shall prescribe a voter registration application
- 25 which may be used to register to vote or change his or her address for
- 26 voting purposes at the same time an elector applies for an original or
- 27 renewal motor vehicle operator's license, an original or renewal state
- 28 identification card, or a replacement thereof. The voter registration
- 29 application shall contain the information required pursuant to section
- 30 32-312 and shall be designed so that it does not require the duplication
- 31 of information in the application for the motor vehicle operator's

- 1 license or state identification card, except that it may require a second
- 2 signature of the applicant. The department and the Secretary of State
- 3 shall make the voter registration application available to any person
- 4 applying for an operator's license or state identification card. The
- 5 application shall be completed at the office of the department by the
- 6 close of business on the third Friday preceding any election to be
- 7 registered to vote at such election. A registration application received
- 8 after the deadline shall not be processed by the election commissioner or
- 9 county clerk until after the election.
- 10 (3) The Department of Motor Vehicles, in conjunction with the
- 11 Secretary of State, shall develop a process to electronically transmit
- 12 voter registration application information received under subsection (2)
- 13 of this section to the election commissioner or county clerk of the
- 14 county in which the applicant resides within the time limits prescribed
- in subsection (4) of this section. The Director of Motor Vehicles shall
- 16 designate an implementation date for the process which shall be on or
- 17 before January 1, 2016.
- 18 (4) The voter registration application information shall be
- 19 transmitted to the election commissioner or county clerk of the county in
- 20 which the applicant resides not later than ten days after receipt, except
- 21 that if the voter registration application information is received within
- 22 five days prior to the third Friday preceding any election, it shall be
- 23 transmitted not later than five days after its original submission. Any
- 24 information on whether an applicant registers or declines to register and
- 25 the location of the office at which he or she registers shall be
- 26 confidential and shall only be used for voter registration purposes and
- 27 verification of voter identification.
- 28 (5) For each voter registration application for which information is
- 29 transmitted electronically pursuant to this section, the Secretary of
- 30 State shall obtain a copy of the electronic representation of the
- 31 applicant's <u>digital image and signature</u> from the Department of Motor

- 1 Vehicles' records of his or her motor vehicle operator's license or state
- 2 identification card for purposes of voter registration and verification
- 3 of voter identification. Each voter registration application
- 4 electronically transmitted under this section shall include information
- 5 provided by the applicant that includes whether the applicant is a
- 6 citizen of the United States, whether the applicant is of sufficient age
- 7 to register to vote, the applicant's residence address, the applicant's
- 8 postal address if different from the residence address, the date of birth
- 9 of the applicant, the party affiliation of the applicant or an indication
- 10 that the applicant is not affiliated with any political party, the
- 11 applicant's motor vehicle operator's license number, the applicant's
- 12 previous registration location by city, county, or state, if applicable,
- 13 and the applicant's signature.
- 14 (6) State agency personnel involved in the voter registration
- 15 process pursuant to this section and section 32-309 shall not be
- 16 considered deputy registrars or agents or employees of the election

- 20 32-309 Upon receipt of a completed voter registration application
- 21 under subsection (2) of section 32-308, any person who issues motor
- 22 vehicle operators' licenses or state identification cards shall, until
- 23 the implementation date designated by the Director of Motor Vehicles
- 24 pursuant to subsection (3) of section 32-308, deliver the completed voter
- 25 registration application to the election commissioner or county clerk of

- 21 (c) The voter has presented a photographic identification which is
- 22 current and valid at the time of the election, or a copy of a utility
- 23 bill, bank statement, paycheck, government check, or other government
- 24 document which is current at the time of the election and which shows the
- 25 same name and residence address of the voter that is on the precinct list
- 26 of registered voters, if the voter registered by mail after January 1,
- 27 2003, and has not previously voted in an election for a federal office
- 28 within the county and a notation appears on the precinct list of
- 29 registered voters that the voter has not previously presented
- 30 identification to the election commissioner or county clerk;
- 31 (d) As instructed by the clerk of election, the registered voter has

- 1 personally written his or her name (i) in the precinct sign-in register
- 2 on the appropriate line which follows the last signature of any previous
- 3 voter or (ii) in the combined document containing the precinct list of
- 4 registered voters and the sign-in register; and
- 5 (e) The clerk has listed on the precinct list of registered voters
- 6 the corresponding line number and name of the registered voter or has
- 7 listed the name of the voter in a separate book as provided in section

- 9 Sec. 9. Section 32-941, Reissue Revised Statutes of Nebraska, is
- 10 amended to read:
- 32-941 Any registered voter permitted to vote early pursuant to section 32-938 may, not more than one hundred twenty days before any
- 13 election and not later than the close of business on the second Friday
- 14 preceding the election, request a ballot for the election to be mailed to
- 15 a specific address. A registered voter shall request a ballot in writing
- 16 to the election commissioner or county clerk in the county where the
- 17 registered voter has established his or her home, and shall indicate his
- or her residence address, the address to which the ballot is to be mailed
- 19 if different, and his or her telephone number if available, and shall
- 20 include the identification number of the voter's valid photographic
- 21 <u>identification issued by the State of Nebraska or, if none, a photocopy</u>

- 4 Sec. 10. Section 32-942, Reissue Revised Statutes of Nebraska, is
- 5 amended to read:
- 32-942 (1) Except as otherwise provided in subsection (2) of this 6 section, a registered voter of this state who anticipates being absent 7 from the county of his or her residence on the day of any election may 8 9 appear in person before the election commissioner or county clerk not more than thirty days prior to the day of election, present valid 10 photographic identification, and obtain his or her ballot. The registered 11 voter shall vote the ballot in the office of the election commissioner or 12 13 county clerk or shall return the ballot to the office not later than the closing of the polls on the day of the election. A registered voter who 14 is present in the county on the day of the election and who chooses to 15 vote on the day of the election shall vote at the polling place assigned 16 to the precinct in which he or she resides unless he or she is returning 17 a ballot for early voting or voting pursuant to section 32-943. 18
- (2) If a person registers to vote and requests a ballot at the same 19 time under this section, he or she shall (a)(i) present valid 20 photographic identification or one of the address confirmation documents 21 22 as prescribed in subdivision (1)(a) of section 32-318.01, (ii) present proof that he or she is a member of the armed forces of the United States 23 24 who by reason of active duty has been absent from his or her place of 25 residence where the member is otherwise eligible to vote, is a member of the United States Merchant Marine who by reason of service has been away 26 from his or her place of residence where the member is otherwise eligible 27 to vote, is a spouse or dependent of a member of the armed forces of the 28 United States or United States Merchant Marine who has been absent from 29 his or her place of residence due to the service of that member, or 30 resides outside the United States and but for such residence would be 31

1 qualified to vote in the state if the state was the last place in which 2 the person was domiciled before leaving the United States, or (iii) state that he or she is elderly or handicapped and has requested to vote by 3 4 alternative means other than by casting a ballot at his or her polling place on election day or (b) fill out vote a ballot which is placed in an 5 envelope with the voter's name and address and other necessary 6 identifying information and kept securely for counting as provided in 7 this subsection. This subsection does not extend the deadline for voter 8 9 registration specified in section 32-302. A ballot cast pursuant to subdivision (b) of this subsection shall be rejected and shall not be 10 counted if the acknowledgment of registration sent to the registrant 11 pursuant to section 32-322 is returned as undeliverable for a reason 12 other than clerical error within ten days after it is mailed or if the 13 voter fails to present valid photographic identification at the election 14 office on or before the Tuesday after the election if applicable, 15 otherwise after such ten-day period, the ballot shall be counted. 16

- 17 (3) This section applies only to a person who appears in person to
  18 obtain a ballot as provided in subsection (1) of this section and does
  19 not apply to a ballot mailed to a voter pursuant to section 32-945.
- Sec. 11. Section 32-943, Reissue Revised Statutes of Nebraska, is amended to read:
- 32-943 (1) Any registered voter who is permitted to vote early 22 pursuant to section 32-938 may appoint an agent to submit a request for a 23 24 ballot for early voting on his or her behalf. The registered voter or his or her agent may request that the ballot be sent to the registered voter 25 by mail or indicate on the request that the agent will personally pick up 26 the ballot for such registered voter from the office of the election 27 28 commissioner or county clerk. A registered voter or an agent acting on behalf of a registered voter shall request a ballot in writing to the 29 election commissioner or county clerk in the county where the registered 30 voter has established his or her residence, and shall indicate the 31

- 1 voter's residence address, the address to which the ballot is to be
- 2 mailed if different, and the voter's telephone number if available and
- 3 precinct if known, and shall present a valid photographic identification
- 4 of the voter and the agent, if any, or include, with the request, the
- 5 identification number of a valid photographic identification issued by
- 6 the State of Nebraska to the voter and the agent, if any, or if the voter
- 7 or agent does not have such identification issued by the State of
- 8 Nebraska, include, with the request, a photocopy of a valid photographic

- 10 registered voter or the voter's agent may use the form published by the
- 11 election commissioner or county clerk pursuant to section 32-808. The
- 12 registered voter or his or her agent shall sign the request.
- 13 (2) A candidate for office at such election and any person serving
- 14 on a campaign committee for such a candidate shall not act as an agent
- 15 for any registered voter requesting a ballot pursuant to this section
- 16 unless such person is a member of the registered voter's family. No
- 17 person shall act as agent for more than two registered voters in any
- 18 election.
- 19 (3) The agent shall pick up the ballot <u>not later than</u> <del>before</del> one
- 20 hour prior to the closing of the polls on election day and deliver the
- 21 ballot to the registered voter. The ballot shall be returned not later
- 22 than the closing of the polls on the day of the election and shall be
- 23 returned in an identification envelope as provided in section 32-947.
- 24 (4) The election commissioner or county clerk shall adopt procedures
- 25 for the distribution of ballots under this section.
- 26 Sec. 12. (1) If a registered voter fails to produce valid
- 27 photographic identification at the polling place and the voter's name
- 28 appears on the precinct list of registered voters for the polling place
- 29 or fails to produce valid photographic identification at the time of
- 30 voting early in person at the office of the election commissioner or
- 31 county clerk, the voter shall fill out a voter identification

- 1 verification envelope.
- 2 (2) Each voter casting a ballot using a voter identification
- 3 verification envelope shall enclose the ballot in an envelope marked
- 4 voter identification verification and shall, by signing the certification
- 5 on the front of the envelope or a separate form attached to the envelope,
- 6 <u>certify to the following facts:</u>
- 7 (a) My name is ......
- 8 (b) I am registered to vote at.....
- 9 (c) I did not provide valid photo identification as required by law.
- 10 (d) I am eligible to vote in this election and I have not voted and
- 11 will not vote in this election except by this ballot.
- 12 <u>(e) I acknowledge that if I do not provide valid photographic</u>
- 13 <u>identification on or before the Tuesday after the election to my county</u>
- 14 election office, my ballot will not be counted.
- 15 (3) The voter shall sign the certification under penalty of election
- 16 falsification. The following statements shall be on the front of the
- 17 envelope or on the attached form: By signing the front of this envelope
- 18 or the attached form you are certifying to the information contained on
- 19 <u>this envelope or the attached form under penalty of election</u>
- 20 <u>falsification</u>. <u>Election falsification is a Class IV felony and may be</u>
- 21 <u>punished by up to two years imprisonment and twelve months post-release</u>
- 22 supervision, a fine of up to ten thousand dollars, or both.
- 23 Sec. 13. Section 32-947, Revised Statutes Cumulative Supplement,
- 24 2022, is amended to read:
- 25 32-947 (1) Upon receipt of an application or other request for a
- 26 ballot to vote early, the election commissioner or county clerk shall
- 27 determine whether the applicant is a registered voter and is entitled to
- 28 vote as requested. If the election commissioner or county clerk
- 29 determines that the applicant is a registered voter entitled to vote
- 30 early and the application was received not later than the close of
- 31 business on the second Friday preceding the election, the election

- 1 commissioner or county clerk shall deliver a ballot to the applicant in
- 2 person or by mail, postage paid. The election commissioner or county
- 3 clerk or any employee of the election commissioner or county clerk shall
- 4 write or cause to be affixed his or her customary signature or initials
- 5 on the ballot.
- 6 (2) An unsealed identification envelope shall be delivered with the
- 7 ballot, and upon the back of the envelope shall be printed a form
- 8 substantially as follows:

- 23 <u>(e) My Nebraska driver's license or state identification card number</u>

- 26 ANY PERSON WHO SIGNS THIS FORM KNOWING THAT ANY OF THE INFORMATION
- 27 IN THE FORM IS FALSE SHALL BE GUILTY OF ELECTION FALSIFICATION, A CLASS
