- 1 A BILL FOR AN ACT relating to corporations and other companies; to amend
- 2 sections 21-102, 21-185, 21-186, 21-188, 21-2202, and 21-2216,
- 3 Reissue Revised Statutes of Nebraska; to redefine terms; to change
- 4 provisions relating to professional service by limited liability
- 5 companies and professional corporations; to harmonize provisions;
- 6 and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 21-102, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 21-102 (RULLCA 102) In the Nebraska Uniform Limited Liability
- 4 Company Act:
- 5 (1) Certificate of organization means the certificate required by
- 6 section 21-117. The term includes the certificate as amended or restated.
- 7 (2) Certificate of registration means either (a) a document prepared
- 8 and issued by a regulatory body or (b) verification that all members,
- 9 managers, professional employees, and agents who are required by law to
- 10 do so are duly licensed or otherwise legally authorized to render the
- 11 professional service for which the limited liability company is organized
- 12 <u>to do business or ancillary service as those which the limited liability</u>
- 13 <u>company renders, through</u> the electronic accessing of the regulatory
- 14 body's licensing records or through compacts or other certifying
- 15 <u>organizations recognized by the regulatory body</u> by the Secretary of
- 16 State.
- 17 (3) Contribution means any benefit provided by a person to a limited
- 18 liability company:
- 19 (A) in order to become a member upon formation of the company and in
- 20 accordance with an agreement between or among the persons that have
- 21 agreed to become the initial members of the company;
- 22 (B) in order to become a member after formation of the company and
- 23 in accordance with an agreement between the person and the company; or
- 24 (C) in the person's capacity as a member and in accordance with the
- 25 operating agreement or an agreement between the member and the company.
- 26 (4) Debtor in bankruptcy means a person that is the subject of:
- 27 (A) an order for relief under Title 11 of the United States Code or
- 28 a successor statute of general application; or
- 29 (B) a comparable order under federal, state, or foreign law
- 30 governing insolvency.

- 3 (B) the principal office of a foreign limited liability company.
- 4 (6) Distribution, except as otherwise provided in subsection (g) of
- 5 section 21-134, means a transfer of money or other property from a
- 6 limited liability company to another person on account of a transferable
- 7 interest.
- 8 (7) Effective, with respect to a record required or permitted to be
- 9 delivered to the Secretary of State for filing under the Nebraska Uniform
- 10 Limited Liability Company Act, means effective under subsection (c) of
- 11 section 21-121.
- 12 (8) Foreign limited liability company means an unincorporated entity
- 13 formed under the law of a jurisdiction other than this state and
- 14 denominated by that law as a limited liability company.
- 15 (9) Limited liability company, except in the phrase foreign limited
- 16 liability company, means an entity formed under the Nebraska Uniform
- 17 Limited Liability Company Act.
- 18 (10) Manager means a person that under the operating agreement of a
- 19 manager-managed limited liability company is responsible, alone or in
- 20 concert with others, for performing the management functions stated in
- 21 subsection (c) of section 21-136.
- 22 (11) Manager-managed limited liability company means a limited
- 23 liability company that qualifies under subsection (a) of section 21-136.
- 24 (12) Member means a person that has become a member of a limited
- 25 liability company under section 21-130 and has not dissociated under
- 26 section 21-145.
- 27 (13) Member-managed limited liability company means a limited
- 28 liability company that is not a manager-managed limited liability
- 29 company.
- 30 (14) Operating agreement means the agreement, whether or not
- 31 referred to as an operating agreement and whether oral, in a record,

- 1 implied, or in any combination thereof, of all the members of a limited
- 2 liability company, including a sole member. The term includes the
- 3 agreement as amended or restated.
- 4 (15) Organizer means a person that acts under section 21-117 to form
- 5 a limited liability company.
- 6 (16) Person means an individual, corporation, business trust,
- 7 estate, trust, partnership, limited liability company, association, joint
- 8 venture, public corporation, government or governmental subdivision,
- 9 agency, or instrumentality, or any other legal or commercial entity.
- 10 (17) Principal office means the principal executive office of a
- 11 limited liability company or foreign limited liability company, whether
- 12 or not the office is located in this state.
- 13 (18) Professional service means any <u>personal service rendered by an</u>
- 14 <u>attorney</u>, a certified public accountant, a public accountant, a dentist,
- 15 <u>an osteopathic physician, a physician and surgeon, a real estate broker,</u>
- 16 an associate real estate broker, a real estate salesperson, or a
- 17 <u>veterinarian.</u> type of personal service to the public which requires as a
- 18 condition precedent to the rendering of such service the obtaining of a
- 19 license or other legal authorization and which includes, but is not
- 20 limited to, personal services rendered by a certified public accountant,
- 21 dentist, osteopathic physician, physician and surgeon, veterinarian, real
- 22 estate broker, associate real estate broker, real estate salesperson, or
- 23 attorney at law. For purposes of the act, those professions pertaining to
- 24 the diagnosis, care, and treatment of humans shall be considered to be of
- 25 the same profession.
- 26 (19) Record means information that is inscribed on a tangible medium
- 27 or that is stored in an electronic or other medium and is retrievable in
- 28 perceivable form.
- 29 (20) Regulatory body means a board, commission, court, or
- 30 governmental authority which is charged with licensing or regulating the
- 31 rendering of a professional service in this state.

1 (21) Sign means, with the present intent to authenticate or adopt a

- 2 record:
- 3 (A) to execute or adopt a tangible symbol; or
- 4 (B) to attach to or logically associate with the record an
- 5 electronic symbol, sound, or process.
- 6 (22) State means a state of the United States, the District of
- 7 Columbia, Puerto Rico, the United States Virgin Islands, or any territory
- 8 or insular possession subject to the jurisdiction of the United States.
- 9 (23) Transfer includes an assignment, conveyance, deed, bill of
- 10 sale, lease, mortgage, trust deed, security interest, encumbrance, gift,
- 11 and transfer by operation of law.
- 12 (24) Transferable interest means the right, as originally associated
- 13 with a person's capacity as a member, to receive distributions from a
- 14 limited liability company in accordance with the operating agreement,
- 15 whether or not the person remains a member or continues to own any part
- 16 of the right.
- 17 (25) Transferee means a person to which all or part of a
- 18 transferable interest has been transferred, whether or not the transferor
- 19 is a member.
- 20 Sec. 2. Section 21-185, Reissue Revised Statutes of Nebraska, is
- 21 amended to read:
- 22 21-185 (1) Each member, manager, professional employee, or agent of
- 23 a limited liability company who renders a professional service shall hold
- 24 a valid license or otherwise be duly authorized to render that
- 25 professional service under the law of this state if such member, manager,
- 26 professional employee, or agent renders a professional service within
- 27 this state or under the law of the state or other jurisdiction in which
- 28 such person renders the professional service.
- 29 (2) Before rendering a professional service, a limited liability
- 30 company shall (a)(i) deliver to the Secretary of State for filing a
- 31 certificate of registration issued to the limited liability company by

- 1 the regulatory body of the particular profession for which the limited
- 2 liability company is organized to do business, which certificate sets
- 3 forth the name and residence address of every member, manager,
- 4 professional employee, and agent of the limited liability company who is
- 5 required by law to be licensed or otherwise authorized to render the
- 6 professional service for which the limited liability company is organized
- 7 to do business or ancillary service as those which the limited liability
- 8 company renders as of the last day of the month preceding the date of
- 9 delivery of the certificate, and (ii) certify that all members, managers,
- 10 professional employees, and agents of the limited liability company who
- 11 are required by law to do so are duly licensed or otherwise authorized to
- 12 render the professional service for which the limited liability company
- 13 is organized to do business or ancillary service as those which the
- 14 <u>limited liability company renders</u> or (b) comply with and qualify under
- the procedures set forth in subsection (2) of section 21-186.
- 16 (3) The registration certificate requirements of this section and
- 17 sections 21-186 to 21-188 shall apply to both limited liability companies
- 18 and foreign limited liability companies.
- 19 (4) Any limited liability company that, prior to the effective date
- 20 of this act, has a certificate of registration pursuant to subsection (1)
- 21 or (2) of section 21-186 may continue to render professional service if
- 22 the certificate of registration is maintained continuously on and after
- 23 the effective date of this act.

- 26 21-186 (1)(a) An application for issuance of a certificate of
- 27 registration shall be made by the limited liability company to the
- 28 regulatory body in writing and shall contain the names of all members,
- 29 managers, professional employees, and agents of the limited liability
- 30 company who are required by law to be licensed or otherwise authorized to
- 31 render the professional service for which the limited liability company

is organized to do business or ancillary service as those which the 1 <u>limited liability company renders</u>, the street address at which the 2 applicant proposes to render a professional service, and such other 3 information as may be required by the regulatory body. If it appears to 4 the regulatory body that each member, manager, professional employee, and 5 agent of the applicant required by law to be licensed is licensed or 6 otherwise authorized to practice the profession for which the applicant 7 is organized to do business and that each member, manager, professional 8 employee, or agent required by law to be licensed or otherwise authorized 9 to practice the profession for which the applicant is organized to do 10 business is not otherwise disqualified from rendering the professional 11 service of the applicant, such regulatory body shall issue a certificate 12 in duplicate upon a form bearing its date of issuance and prescribed by 13 such regulatory body certifying that the proposed or existing limited 14 liability company complies with the provisions of the Nebraska Uniform 15 16 Limited Liability Company Act and of the applicable rules and regulations of the regulatory body. Each applicant for such certificate shall pay the 17 regulatory body a fee of twenty-five dollars for the issuance of the 18 19 certificate.

- (b) One copy of a certificate of registration issued pursuant to 20 this subsection shall be prominently displayed to public view upon the 21 premises of the principal place of business of the limited liability 22 company, and, except as provided in subsection (2) of this section, one 23 24 copy shall be delivered for filing to the Secretary of State who shall charge a fee as specified in section 21-192 for filing the same. The 25 certificate shall be delivered to the Secretary of State for filing with 26 the certificate of organization. A certificate of registration bearing an 27 issuance date more than twelve months old shall not be eligible for 28 filing by the Secretary of State. 29
- 30 (2) When licensing records of regulatory bodies are electronically accessible to the Secretary of State, the regulatory body, in conjunction

with the Secretary of State, shall develop an automated process to allow 1 the Secretary of State to electronically access and verify the records. 2 The access of the records shall be made in lieu of a certificate of 3 registration being prepared and issued by the regulatory body for 4 delivery to the Secretary of State for filing. The limited liability 5 company shall deliver to the Secretary of State for filing an application 6 7 setting forth the names of all members, managers, professional employees, and agents of such limited liability company who are required by law to 8 9 be licensed or otherwise authorized to render the professional service for which the limited liability company is organized to do business, or 10 ancillary service as those which the limited liability company renders, 11 as of the last day of the month preceding the date of application and 12 13 shall deliver to the Secretary of State for filing an annual update thereafter. The application shall be completed on a form prescribed by 14 the Secretary of State and shall contain such other information as the 15 16 Secretary of State may require. The application shall be accompanied by a license verification fee as specified in section 21-192. 17 The Secretary of State shall verify that all members, managers, 18

professional employees, and agents who are required by law to do so are 19 duly licensed or otherwise legally authorized to render the professional 20 service for which the applicant is organized to do business or ancillary 21 service as those which the applicant limited liability company renders 22 23 through electronic accessing of the regulatory body's records or through 24 compacts or other certifying organization recognized by the regulatory body. If any member, manager, professional employee, or agent who is 25 required by law to be licensed or otherwise authorized to render the 26 professional service for which the limited liability company is organized 27 to do business, or ancillary service as those which the limited liability 28 company renders, is not licensed or otherwise legally authorized to 29 render the professional service for which the limited liability company 30 is organized to do business or ancillary service as those which the 31

limited liability company renders, the limited liability company shall be 1 2 suspended. The suspension shall remain in effect and a biennial report shall not be delivered to the Secretary of State for filing or filed by 3 4 the Secretary of State until the limited liability company attests in 5 writing that all members, managers, professional employees, or agents who are required by law to be licensed or otherwise authorized to render the 6 7 professional service for which the limited liability company is organized to do business, or ancillary service as those which the limited liability 8 9 company renders, are duly licensed or otherwise legally authorized to render the professional service for which the limited liability company 10 is organized to do business or ancillary service as those which the 11 <u>limited liability company renders</u> and that information is verified by the 12 13 Secretary of State or all unlicensed or unauthorized members, managers, professional employees, or agents are no longer members, managers, 14 professional employees, or agents of the limited liability company. 15

Sec. 4. Section 21-188, Reissue Revised Statutes of Nebraska, is amended to read:

21-188 A regulatory body may, upon a form prescribed by it, suspend 18 19 or revoke any certificate of registration issued to any limited liability company pursuant to subsection (1) of section 21-186 upon the suspension 20 revocation of the license or other authorization to render a 21 professional service by any member, manager, professional employee, or 22 agent of the limited liability company who is required by law to be 23 24 licensed or otherwise authorized to render the professional service for 25 which the limited liability company is organized to do business or ancillary service as those which the limited liability company renders. 26 Notice of such suspension or revocation shall be provided to the limited 27 28 liability company affected by sending by certified or registered mail a certified copy of such suspension or revocation to the limited liability 29 company at its principal place of business set forth in the certificate 30 so suspended or revoked. At the same time, the regulatory body shall 31

- 1 forward by regular mail a certified copy of such suspension or revocation
- 2 to the Secretary of State who shall remove the suspended or revoked
- 3 registration certificate from his or her files and deliver it to the

- 6 amended to read:
- 7 21-2202 For purposes of the Nebraska Professional Corporation Act,
- 8 unless the context otherwise requires:
- 9 (1) Certificate of registration or registration certificate from or
- 10 by the regulating board means either <u>(a)</u> a document prepared and issued
- by the regulating board or (b) verification that all directors, officers,
- 12 <u>shareholders</u>, and professional employees listed on the application filed
- 13 <u>with the Secretary of State, except for the secretary and assistant</u>
- 14 <u>secretary, are duly licensed or otherwise legally authorized to render</u>
- 15 the professional service or an ancillary service for which the
- 16 <u>professional corporation is organized, through</u> the electronic accessing
- 17 of the regulating board's licensing records or through compacts or other
- 18 <u>certifying organizations recognized by the regulatory body</u> by the
- 19 Secretary of State;
- 20 (2) Professional corporation means a corporation which is organized
- 21 under the act for the specific purpose of rendering professional service
- 22 and which has as its shareholders only individuals who themselves are
- 23 duly licensed or otherwise legally authorized within this state to render
- 24 the same professional service as the corporation;
- 25 (3) Professional service means any personal services rendered by an
- 26 attorney at law, a certified public accountant, a public accountant, a
- 27 dentist, an osteopathic physician, a physician and surgeon, a real estate
- 28 broker, an associate real estate broker, a real estate salesperson, or a
- 29 veterinarian. For purposes of the act, those professions pertaining to
- 30 the diagnosis, care, and treatment of humans shall be considered to be of
- 31 the same profession; and

- 1 (4) Regulating board means a board which is charged with the 2 licensing and regulating of the practice or profession which the 3 professional corporation is organized to render.
- Sec. 6. Section 21-2216, Reissue Revised Statutes of Nebraska, is amended to read:
- 21-2216 (1) No corporation shall open, operate, or maintain an 6 establishment or do business for any purposes set forth in the Nebraska 7 8 Professional Corporation Act without (a) filing with the Secretary of 9 State a certificate of registration from the regulating board of the particular profession for which the professional corporation is organized 10 to do business, which certificate shall set forth the name and residence 11 addresses of all shareholders as of the last day of the month preceding 12 13 such filing, and (b) certifying that all shareholders, directors, and 14 officers, except the secretary and the assistant secretary, are duly licensed to render the same professional services as those for which the 15 16 corporation was organized. Application for a certificate of registration shall be made by the professional corporation to the regulating board in 17 writing and shall contain the names of all officers, directors, 18 shareholders, and professional employees of the professional corporation, 19 the street address at which the applicant proposes to perform 20 professional services, and such other information as may be required by 21 22 the regulating board.
- 23 (2) If it appears to the regulating board that each shareholder, 24 officer, director, and professional employee of the applicant, except the secretary and the assistant secretary, is licensed to practice the 25 profession of the applicant and that each shareholder, officer, director, 26 or professional employee is not otherwise disqualified from performing 27 28 the professional services of the applicant, such regulating board shall certify, in duplicate upon a form bearing its date of issuance and 29 prescribed by such regulating board, that such proposed or existing 30 professional corporation complies with the provisions of the act and of 31

- 1 the applicable rules and regulations of such regulating board. Each
- 2 applicant for such registration certificate shall pay such regulating
- 3 board a fee of twenty-five dollars for the issuance of such duplicate
- 4 certificate.
- 5 (3) One copy of such certificate shall be prominently exposed to
- 6 public view upon the premises of the principal place of business of each
- 7 professional corporation organized under the act, and one copy shall be
- 8 filed by the professional corporation with the Secretary of State who
- 9 shall charge a fee as specified in section 21-205. The certificate from
- 10 the regulating board shall be filed in the office of the Secretary of
- 11 State together with the articles of incorporation. A registration
- 12 certificate bearing an issuance date more than twelve months old shall
- 13 not be eligible for filing with the Secretary of State.
- 14 (4) When licensing records of regulating boards are electronically
- 15 accessible, the regulatory body, in conjunction with the Secretary of
- 16 State, shall <u>develop an automated process to allow the Secretary of State</u>
- 17 <u>to electronically</u> access <u>and verify</u> the records. The access shall be made
- 18 in lieu of the certificate of registration or registration certificate
- 19 being prepared and issued by the regulating board. The professional
- 20 corporation shall file with the Secretary of State an application setting
- 21 forth the name and residence addresses of all officers, directors,
- 22 shareholders, and professional employees as of the last day of the month
- 23 preceding the date of the application and shall file with the Secretary
- 24 of State an annual update thereafter. Each application shall be
- 25 accompanied by a licensure verification fee as specified in section
- 26 21-205. The Secretary of State shall verify that all of the directors,
- 27 officers, shareholders, and professional employees listed on the
- 28 application, except for the secretary and assistant secretary, are duly
- 29 licensed or otherwise legally authorized to render the same professional
- 30 service or an ancillary service as those for which the professional
- 31 corporation was organized. Verification shall be done by electronically

- 1 accessing the regulating board's licensing records or through compacts or
- 2 <u>other certifying organizations recognized by the regulatory body</u>. If any
- 3 director, officer, shareholder, or professional employee is not licensed
- 4 or otherwise legally authorized to perform the professional service that
- 5 the professional corporation was organized to render, or ancillary
- 6 service as those which the professional corporation renders, the
- 7 corporation will be suspended. The biennial report and tax cannot be
- 8 filed and paid in the office of the Secretary of State until the
- 9 corporation attests in writing that the director, officer, shareholder,
- 10 or professional employee is licensed or otherwise legally authorized to
- 11 practice, which shall be verified by the Secretary of State, or is no
- 12 longer a director, officer, shareholder, or professional employee of the
- 13 corporation. When the biennial report and the tax become delinquent, the
- 14 corporation shall be dissolved for nonpayment of taxes in compliance with
- 15 section 21-323.
- 16 Sec. 7. Original sections 21-102, 21-185, 21-186, 21-188, 21-2202,
- 17 and 21-2216, Reissue Revised Statutes of Nebraska, are repealed.
