## LEGISLATIVE BILL 319

Approved by the Governor April 21, 1973

Introduced by Richendifer, 16

AN ACT to amend section 60-412, Reissue Revised Statutes of Nebraska, 1943, relating to motor vehicles; to change the fee for a certified abstract of an operating record; to provide for the disposition and use of fees; to repeal the original section; and to declare an emergency. Be it enacted by the people of the State of Nebraska,

Section 1. That section 60-412, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

60-412. The director shall assign distinguishing number to each license issued and shall keep an index record of the same which shall be open to public inspection. The department shall, upon request of applicant, furnish a certified abstract of operating record of any person and shall be entitled charge such applicant a fee of seventy-five cents therefor rer abstract. Fifty per cent of the fee on abstracts shall be deposited in the Drivers' License Abstracts Computerization Fund, which is hereby created. Such fund shall be used to develop and operate a system of utilizing a computer to store and print such abstracts. Where-request-is-made-by--one--applicant--for two-or-more-different-abstracts-to-be--furnished--at--one time,-the-department-shall-furnish-the-same-upon--payment of-a-fee-in-accordance-with-the-following-schedule:

- (1) -For-two-different-abstracts; --a--fee--of--one dollar-and-twenty-cents;
- (2)-For-three-different-abstracts,-a-fee--of--one dollar-and-sixty-cents;
- (3)-For-four-different-abstracts;-a--fee--of--one dollar-and-ninety-five-cents;
- (4)-For-five-different-abstracts;-a--fee--of--two dollars-and-twenty-five-cents;
- (5)-For-six-different-abstracts,--a-fee--of--two dollars-and-fifty-cents;

(6)-For-seven-different-abstracts;-a-fee--cf--two dollars-and-seventy-five-cents;

(7)-for-eight-different-abstracts,-a-fee-cf-three dollars;

(8)-For-nine-different-abstracts,-a-fee-of--three dollars-and-twenty-five-cents;-and

(9)-For-ten-different-abstracts;-a-fee--of--three dollars-and-fifty-cents;

The director shall also keep a record of all applications for licenses that are disapproved with a brief statement of the reason for disapproval of the application. The motor vehicle operator's license shall he in the form of a card of a size that may be conveniently carried on the person. Each license card shall carry the following statements: Name; age; place of residence; post-office address; a trief rersonal description of the licensee sufficient for identification; and such other facts and information, not inconsistent with this act, as the director may determine.

Sec. 2. That original section 60-412, Reissue Revised Statutes of Nebraska, 1943, is repealed.

Sec. 3. Since an emergency exists, this act shall be in full force and take effect, from and after its passage and approval, according to law.
