LB 984 prohibits drug manufacturers or wholesale drug distributors from directly or indirectly denying, restricting, prohibiting, refusing, withholding or otherwise interfering with the acquisition of a 340B drug by, or delivery of such drug to, any pharmacy that is under contract with the 340B entity. A 340B drug is defined as a drug that a 340B entity may purchase at a reduced price pursuant to 42 U.S.C 256b.

LB 984 also allows the Attorney General or any county attorney to institute an action for an injunction against any person violating the bill's provisions.
