Explanation of Estimate:

LB 1411 would appropriate \$5,100,000 of federal Coronavirus State Fiscal Recovery Fund pursuant to the federal American Rescue Plan Act of 2021, 42 U.S.C. 802 to Program 569 of the Department of Transportation. The purpose of the funding is for NDOT to award a grant to a county with a population of more than twenty thousand inhabitants and less than thirty thousand inhabitants for bridge construction projects.

Under the American Rescue Plan Act of 2021 there are three different pathways in which funding can be utilized. To utilize the federal funding projects must be contracted by December 31, 2024 and all funds expended by September 30, 2026 using one of the specified pathways. Due to the restrictive regulations of how NDOT can utilized the federal funds under the various pathways the fiscal impact is undetermined at this time.
