Section 1. The Legislature finds that the ruling of the 1 2 United States District Court for the District of Nebraska in Jones 3 v. Gale, 405 F. Supp. 2d 1066, D. Neb. 2005, and subsequent rulings on appeal affirming such ruling holding Article XII, section 8, of 4 5 the Constitution of Nebraska to be invalid, enjoined, or limited in 6 application has significant implications for the future structure, 7 development, and progress of agricultural production in Nebraska. 8 Sec. 2. (1) It is the intent of the Legislature to 9 support and facilitate a study by the Agriculture Committee of 10 the Legislature to identify policy instruments available to the 11 Legislature and the people of Nebraska, including, as appropriate, 12 but not necessarily requiring or limited to, modification of 13 Article XII, section 8, of the Constitution of Nebraska, in order 14 to foster and enhance legal, social, and economic conditions in 15 Nebraska consistent with and which advance those state interests that exist in the structure, development, and progress of 16 agricultural production. 17 18 (2) Within the limits of funds appropriated for such 19 purpose, the Executive Board of the Legislative Council may, in 20 coordination and cooperation with the Agriculture Committee of 21 the Legislature, commission experts in the fields of agricultural 22 economics, agricultural law, commerce clause jurisprudence, and 23 other areas of study and practice to provide assistance, specific research or reports, or presentations in order to assist the 24 25 Agriculture Committee of the Legislature in carrying out the intent LB 516 LB 516

- 2 Sec. 3. (1) It is the intent of the Legislature that
- 3 the Attorney General perform, acquire, and otherwise cause to be
- 4 made available such research as may be appropriate to inform and
- 5 assist the Agriculture Committee of the Legislature in identifying
- 6 policy instruments available to the Legislature and the people of
- 7 Nebraska, including, as appropriate, but not necessarily requiring
- 8 or limited to, modification of Article XII, section 8, of the
- 9 Constitution of Nebraska, in order to foster and enhance legal,
- 10 social, and economic conditions in Nebraska consistent with and
- 11 which advance those state interests that exist in the structure,
- 12 <u>development</u>, and progress of agricultural production in Nebraska.
- 13 (2) The Attorney General may contract with experts in the
- 14 fields of agricultural economics, agricultural law, commerce clause
- 15 jurisprudence, and other areas of study and practice to assist
- 16 the Attorney General in carrying out the intent of the Legislature
- 17 under this section.
- 18 Sec. 4. Since an emergency exists, this act takes effect
- 19 when passed and approved according to law.
