A BILL

- 1 FOR AN ACT relating to birth certificates; to amend section 71-601,
- 2 Revised Statutes Cumulative Supplement, 2006; to provide
- 3 for birth certificates for stillbirths; to harmonize
- 4 provisions; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) For purposes of this section:
- 2 (a) Certificate of birth resulting in stillbirth means a
- 3 birth certificate issued to record the birth of a stillborn child;
- 4 and
- 5 (b) Stillbirth means an unintended, intrauterine fetal
- 6 death occurring in this state after the twentieth week of
- 7 gestation.
- 8 (2) The person who is required to file a fetal death
- 9 certificate under section 71-606 shall advise the parent or parents
- 10 of a stillborn child:
- 11 (a) That a parent may, but is not required to, request
- 12 the preparation of a certificate of birth resulting in stillbirth;
- 13 (b) That a parent may obtain a certificate of birth
- 14 resulting in stillbirth by contacting the department to request the
- 15 certificate and paying the required fee; and
- 16 (c) Regarding the way or ways in which a parent may
- 17 contact the department to request the certificate.
- 18 (3) A parent may provide a name for a stillborn child
- 19 on the request for a certificate of birth resulting in stillbirth.
- 20 If the requesting parent does not wish to provide a name, the
- 21 department shall fill in the certificate with the name "baby boy"
- 22 or "baby girl" and the last name of the parent. The name of the
- 23 stillborn child provided on or later added by amendment to the
- 24 certificate of birth resulting in stillbirth shall be the same name
- 25 as placed on the original or amended fetal death certificate.

1 (4) A certificate of birth resulting in stillbirth shall

- 2 include the state file number of the corresponding fetal death
- 3 certificate.
- 4 (5) The department shall prescribe the form and content
- 5 of a certificate of birth resulting in stillbirth and shall specify
- 6 the information necessary to prepare the certificate.
- 7 (6) The department shall not use a certificate of birth
- 8 resulting in stillbirth to calculate live birth statistics.
- 9 (7) A parent may request a certificate of birth resulting
- 10 in stillbirth without regard to the date on which the fetal death
- 11 certificate was issued. A parent may request a certificate of birth
- 12 resulting in stillbirth without regard to whether the fetal death
- occurred on, before, or after the effective date of this act.
