## A BILL

1	FOR AN	ACT relating to police animals; to amend section 28-906,
2		Reissue Revised Statutes of Nebraska, and section 28-1008,
3		Revised Statutes Cumulative Supplement, 2006; to redefine
4		the term for certain crimes; and to repeal the original
5		sections.

6 Be it enacted by the people of the State of Nebraska,

Section 1. Section 28-906, Reissue Revised Statutes of
 Nebraska, is amended to read:

28-906. (1) A person commits the offense of obstructing a 3 4 peace officer, when, by using or threatening to use violence, force, 5 physical interference, or obstacle, he or she intentionally obstructs, 6 impairs, or hinders (a) the enforcement of the penal law or the 7 preservation of the peace by a peace officer or judge acting under 8 color of his or her official authority or (b) a police animal assisting a peace officer acting pursuant to the peace officer's 9 10 official authority.

11 (2) For purposes of this section, police animal means (a) 12 a horse <del>or dog</del> owned or controlled by the State of Nebraska <u>a</u> 13 law enforcement agency for the purpose of assisting a Nebraska 14 state trooper acting pursuant to his or her official authority. peace officer in the performance of his or her official duties or (b) 15 16 a dog, certified as a police service dog pursuant to standards recognized by the Police Standards Advisory Council, owned or 17 controlled by a law enforcement agency for the purpose of assisting a 18 peace officer in the performance or his or her official duties and 19 such officer is certified as a police service dog handler pursuant to 20 21 standards recognized by the Police Standards Advisory Council. 22 (3) Obstructing a peace officer is a Class I misdemeanor. 23 Sec. 2. Section 28-1008, Revised Statutes Cumulative 24 Supplement, 2006, is amended to read:

25 28-1008. For purposes of sections 28-1008 to 28-1017:
26 (1) Abandon means to leave any animal for any length of time
27 without making effective provision for its food, water, or other care

as is reasonably necessary for the animal's health;

2 (2) Animal means any vertebrate member of the animal
3 kingdom. The term does not include an uncaptured wild creature;
4 (3) Cruelly mistreat means to knowingly and intentionally
5 kill, maim, disfigure, torture, beat, mutilate, burn, scald, or
6 otherwise inflict harm upon any animal;

7 (4) Cruelly neglect means to fail to provide any animal in
8 one's care, whether as owner or custodian, with food, water, or other
9 care as is reasonably necessary for the animal's health;

(5) Humane killing means the destruction of an animal by a 10 11 method which causes the animal a minimum of pain and suffering; (6) Law enforcement officer means any member of the Nebraska 12 State Patrol, any county or deputy sheriff, any member of the police 13 14 force of any city or village, or any other public official authorized 15 by a city or village to enforce state or local animal control laws, 16 rules, regulations, or ordinances. Law enforcement officer also includes any inspector under the Commercial Dog and Cat Operator 17

18 Inspection Act to the extent that such inspector may exercise the 19 authority of a law enforcement officer under section 28-1012 while in 20 the course of performing inspection activities under the Commercial 21 Dog and Cat Operator Inspection Act; and

(7) Police animal means (a) a horse or dog owned or controlled by the State of Nebraska <u>a law enforcement agency</u> for the purpose of assisting a Nebraska state trooper <u>law enforcement</u> <u>officer</u> in the performance of his or her official enforcement duties <u>or (b) a dog, certified as a police service dog pursuant to standards</u> <u>recognized by the Police Standards Advisory Council, owned or</u>
