1 Section 1. Section 60-462, Revised Statutes Cumulative

- 4 of this act shall be known and may be cited as the Motor Vehicle
- 5 Operator's License Act.
- 6 Sec. 2. Section 60-474, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 60-474 Operator's or driver's license shall mean any
- 9 license, or permit, or card to operate a motor vehicle issued under
- 10 the laws of this state, including:
- 11 (1) Any replacement or duplicate license or instruction
- 12 permit;
- 13 (2) The privilege of any person to drive a motor vehicle
- 14 whether such person holds a valid license;
- 15 (3) Any nonresident's operating privilege which shall

- 4 shall be classified as follows:
- 5 (1) Class O license. The operator's license which
- 6 authorizes the person to whom it is issued to operate on highways
- 7 any motor vehicle except a commercial motor vehicle or motorcycle;
- 8 (2) Class M license. The operator's license or
- 9 endorsement on a Class O license, provisional operator's permit,
- 10 learner's permit, school permit, or commercial driver's license
- 11 which authorizes the person to whom it is issued to operate a
- 12 motorcycle on highways;
- 13 (3) CDL-commercial driver's license. The operator's
- 14 license which authorizes the person to whom it is issued to operate
- 15 a class of commercial motor vehicles or any motor vehicle, except
- 16 a motorcycle, on highways;
- 17 (4) RCDL-restricted commercial driver's license. The

- 13 purposes of operating farm tractors and other motorized implements
- 14 of farm husbandry on highways in accordance with the requirements

- 17 conjunction with a Class O license or commercial driver's license
- 18 authorizes a person to operate a commercial motor vehicle for
- 19 learning purposes when accompanied by a person who is at least
- 20 twenty-one years of age;
- 21 (9) LPD-learner's permit. A permit issued in accordance
- 22 with the requirements of section 60-4,123 to a person at least
- 23 fifteen years of age which authorizes the person to operate a motor
- 24 vehicle, except a commercial motor vehicle, for learning purposes
- 25 when accompanied by a licensed operator who is at least twenty-one

1 years of age and who possesses a valid operator's license issued by

- 2 this state or another state;
- 3 (10) LPE-learner's permit. A permit issued to a person at
- 4 least fourteen years of age which authorizes the person to operate
- 5 a motor vehicle, except a commercial motor vehicle, while learning
- 6 to drive in preparation for application for a school permit;
- 7 (11) EDP-employment driving permit. A permit issued to
- 8 a person which authorizes the person to operate a motor vehicle,
- 9 except a commercial motor vehicle, pursuant to the requirements of
- 10 sections 60-4,129 and 60-4,130;
- 11 (12) SEP-seasonal permit. A permit issued to a person
- 12 who holds a restricted commercial driver's license authorizing
- 13 the person to operate a commercial motor vehicle, as prescribed
- 14 by section 60-4,146.01, for no more than one hundred eighty
- 15 consecutive days in any twelve-month period. The seasonal permit
- 16 shall be valid and run from the date of original issuance of the
- 17 permit for one hundred eighty days and from the date of annual
- 18 revalidation of the permit; and
- 19 (13) MHP-medical hardship driving permit. A permit issued
- 20 to a person which authorizes the person to operate a motor vehicle,

- 8 of the State of Nebraska until the person has obtained an

eighteen years or an individual applying for a driving privilege 1 2 card, each individual applying for an operator's license or a 3 state identification card shall furnish proof of date of birth and identity by a valid Nebraska operator's license, a valid 4 5 Nebraska learner's permit, a valid Nebraska school permit, a valid operator's license from another state or jurisdiction of the 6 7 United States, a certified birth certificate, a certified birth 8 registration, a valid United States passport, a valid United States 9 military identification card, United States military discharge 10 papers, other United States-based identification as approved by 11 the director, or information preserved in the digital system 12 implemented under section 60-484.01. 13 (b) Any individual under the age of eighteen years 14 applying for an operator's license or a state identification card 15 shall provide a certified copy of his or her birth certificate, a certified birth registration, or other reliable proof of his or 16 17 her identity and age accompanied by a certification signed by a

18 parent or guardian explaining the inability to produce a copy of

19 such birth certificate. The applicant may be required to furnish

20 proof to the examiner that the parent or guardian signing the

(c) (i) An individual applying for a driving privilege

card shall provide reliable proof of his or her identity and age,

proof of residency in Nebraska, or other proof or documentation

satisfactory to the director as prescribed by the rules and

1 regulations adopted and promulgated pursuant to the Motor Vehicle

- 2 Operator's License Act which may include:
- 3 (A) An original or certified copy of a birth certificate
- 4 which was issued by the United States, a state or territory of the
- 5 United States, or a foreign government;
- 6 (B) A document listed in subdivision (ii) of this
- 7 subdivision; or
- 8 (C) Any other proof of age and identity that is
- 9 satisfactory to the director.
- 10 (ii) The rules and regulations shall provide that the
- 11 following documents are acceptable as proof of age and identity:
- 12 (A) A social security card or a letter from the Internal
- 13 Revenue Service stating that an individual taxpayer number has been
- 14 issued to the applicant;
- 15 (B) A current or expired passport issued by the United
- 16 States, a territory of the United States, or a foreign government;
- 17 (C) A valid military identification card issued by the
- 18 United States, a territory of the United States, or a foreign
- 19 government;
- 20 (D) A certificate of naming issued by a religious

- 7 60-490 (1) Operators' licenses issued to persons required
- 8 to use bioptic or telescopic lenses as provided in section 60-4,118
- 9 shall expire annually on the licensee's birthday for all such
- 10 licenses issued prior to January 1, 2007, and on the licensee's
- 11 birthday in the second year after issuance, unless specifically
- 12 restricted to a shorter renewal period as determined under section

- 9 60-4,119 (1) All state identification cards and
- 10 operators' licenses, except farm permits and except as otherwise
- 11 provided in subsection (2) of this section and section 60-4,120,
- 12 shall include a color photograph or a digital image of the
- 13 cardholder or licensee as provided in section 60-484.02. State
- 14 identification cards and operators' licenses shall be issued by the
- 15 county treasurer or the Department of Motor Vehicles. The director
- 16 shall negotiate and enter into a contract to provide the necessary
- 17 equipment, supplies, and forms for the issuance of the licenses and
- 18 cards. All costs incurred by the Department of Motor Vehicles under
- 19 this section shall be paid by the state out of appropriations made
- 20 to the department. All costs of taking the photographs or digital
- 21 images shall be paid by the issuer from the fees provided to the

- 7 definition may be amended from time to time by the Legislature,
- 8 shall be of a distinct designation, of a type prescribed by the
- 9 director, from the operator's license or state identification card
- 10 of a person who is not a minor.
- 11 (4) A driving privilege card shall be of a distinct
- 12 designation, of a type prescribed by the director, from
- 13 other operators' licenses. The card shall clearly display the
- 14 phrase, "For driving privileges only, not for other government
- 15 identification purposes."
- 16 Sec. 9. A driving privilege card shall be issued with
- 17 a classification authorized in subdivision (1), (5), or (9) of
- 18 section 60-480 and shall be subject to the same issuance and
- 19 renewal requirements and fees as the operator's license of the same
- 20 classification except as otherwise provided in section 60-4,115.
- 21 Sec. 10. (1) A driving privilege card may only be used
- 22 for verifying that the person is licensed to operate a motor
- 23 vehicle and checking his or her driving record. The requirements,
- 24 endorsements, fees, restrictions, sanctions, and other provisions

- 1 the Road, and sections 28-306 and 28-394 apply to driving privilege
