A BILL

- FOR AN ACT relating to motor vehicles; to amend sections 60-301,
 60-393, 60-395, 60-396, and 60-3,104, Revised Statutes
 Cumulative Supplement, 2006; to provide for Gold Star
 plates; to change provisions for message plates; to
 harmonize provisions; to provide an operative date; and
 to repeal the original sections.
- Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-301, Revised Statutes Cumulative

- 2 Supplement, 2006, is amended to read:
- 3 60-301 Sections 60-301 to 60-3,220 and sections 2 and 3
- 4 of this act shall be known and may be cited as the Motor Vehicle
- 5 Registration Act.
- 6 Sec. 2. (1) The department shall design license plates
- 7 to be known as Gold Star plates. The department shall create
- 8 designs reflecting support for the United States Armed Forces
- 9 in consultation with the Department of Veterans' Affairs and the
- 10 Military Department. The Department of Veterans' Affairs shall
- 11 recommend the design of the plate to the Department of Motor
- 12 Vehicles. The design shall be selected on the basis of (a)
- 13 enhancing the marketability of the plates to supporters of the
- 14 United States Armed Forces and (b) limiting the manufacturing cost
- 15 of each plate to an amount less than or equal to the amount charged
- 16 for license plates pursuant to section 60-3,102. The department
- 17 shall make applications available for this type of plate when it
- 18 is designed. The department may adopt and promulgate rules and
- 19 regulations to carry out this section and section 2 of this act.
- 20 (2) One type of Gold Star plate shall be consecutively
- 21 numbered plates. The department shall:
- 22 (a) Number the plates consecutively beginning with the
- 23 number one, using numerals the size of which maximizes legibility
- 24 and limiting the numerals to five characters or less; and
- 25 (b) Not use a county designation or any characters other

1 than numbers on the plates.

2 (3) One type of Gold Star plate shall be personalized 3 message plates. Such plates shall be issued subject to the same conditions specified for personalized message license plates in 4 5 section 60-3,118, except that a maximum of five characters may be 6 used. 7 Sec. 3. (1) A person may apply to the department for Gold 8 Star plates in lieu of regular license plates on an application 9 prescribed and provided by the department for any motor vehicle 10 or cabin trailer, except for a commercial truck registered for 11 over ten tons gross weight or a motorcycle. An applicant receiving 12 a Gold Star plate for a farm truck with a gross weight of over 13 sixteen tons or for a commercial truck or truck-tractor registered 14 for a gross weight of five tons or over shall affix the appropriate 15 tonnage decal to the plate. The department shall make forms available for such applications through the county treasurers or 16 17 designated county officials. The license plates shall be issued 18 upon payment of the license fee described in subsection (2) of this 19 section and furnishing proof satisfactory to the department that 20 the applicant is a surviving spouse, whether remarried or not, or a 21 parent, grandparent, sibling, or child of a person who died while 22 on active duty in the military service of the United States. Only 23 one motor vehicle or trailer owned by the applicant shall be so 24 licensed at any one time.

25 (2)(a) Each application for initial issuance of

1 consecutively numbered Gold Star plates shall be accompanied by

- 2 a fee of fifteen dollars. An application for renewal of such
- 3 plates shall be accompanied by a fee of fifteen dollars. County
- 4 treasurers or designated county officials collecting fees for
- 5 renewals pursuant to this subdivision shall remit them to the State
- 6 Treasurer. The State Treasurer shall credit five dollars of the fee
- 7 for initial issuance and renewal of such plates to the Department
- 8 of Motor Vehicles Cash Fund and ten dollars of the fee to the
- 9 Nebraska Veteran Cemetery System Operation Fund.
- 10 <u>(b) Each application for initial issuance of personalized</u>
 11 message Gold Star plates shall be accompanied by a fee of forty
- 12 dollars. An application for renewal of such plates shall be
- 13 accompanied by a fee of forty dollars. County treasurers or
- 14 designated county officials collecting fees for renewals pursuant
- 15 to this subdivision shall remit them to the State Treasurer. The
- 16 State Treasurer shall credit thirty dollars of the fee for initial
- 17 <u>issuance and renewal of such plates to the Department of Motor</u>
- 18 Vehicles Cash Fund and ten dollars of the fee to the Nebraska
- 19 Veteran Cemetery System Operation Fund.
- 20 (3) When the department receives an application for Gold
- 21 Star plates, the department shall deliver the plates to the county
- 22 treasurer or designated county official of the county in which the
- 23 motor vehicle or cabin trailer is registered. The county treasurer
- 24 or designated county official shall issue Gold Star plates in
- 25 lieu of regular license plates when the applicant complies with

1 the other provisions of the Motor Vehicle Registration Act for

- 2 registration of the motor vehicle or cabin trailer. If Gold Star
- 3 plates are lost, stolen, or mutilated, the licensee shall be issued
- 4 replacement license plates upon request and without charge.
- 5 (4) The owner of a motor vehicle or cabin trailer
- 6 bearing Gold Star plates may apply to the county treasurer or
- 7 designated county official to have such plates transferred to a
- 8 motor vehicle other than the vehicle for which such plates were
- 9 originally purchased if such vehicle is owned by the owner of the
- 10 plates. The owner may have the unused portion of the fee for the
- 11 plates credited to the other vehicle which will bear the plates
- 12 at the rate of eight and one-third percent per month for each
- 13 full month left in the registration period. Application for such
- 14 transfer shall be accompanied by a fee of three dollars. Fees
- 15 collected pursuant to this subsection shall be remitted to the
- 16 State Treasurer for credit to the Department of Motor Vehicles Cash
- 17 Fund.
- 18 (5) If the cost of manufacturing Gold Star plates at
- 19 any time exceeds the amount charged for license plates pursuant to
- 20 section 60-3,102, any money to be credited to the Nebraska Veteran
- 21 <u>Cemetery System Operation Fund shall instead be credited first to</u>
- 22 the Highway Trust Fund in an amount equal to the difference between
- 23 the manufacturing costs of Gold Star plates and the amount charged
- 24 pursuant to section 60-3,102 with respect to such plates and the
- 25 remainder shall be credited to the Nebraska Veteran Cemetery System

- 1 Operation Fund.
- Sec. 4. Section 60-393, Revised Statutes Cumulative
- 3 Supplement, 2006, is amended to read:
- 4 60-393 Any owner who has two or more motor vehicles
- 5 or trailers required to be registered under the Motor Vehicle
- 6 Registration Act may register all such motor vehicles or trailers
- 7 on a calendar-year basis or on an annual basis for the same
- 8 registration period beginning in a month chosen by the owner. When
- 9 electing to establish the same registration period for all such
- 10 motor vehicles or trailers, the owner shall pay the registration
- 11 fee, the motor vehicle tax imposed in section 60-3,185, and
- 12 the motor vehicle fee imposed in section 60-3,190 on each motor
- 13 vehicle for the number of months necessary to extend its current
- 14 registration period to the registration period under which all
- 15 such motor vehicles or trailers will be registered. Credit shall
- 16 be given for registration paid on each motor vehicle or trailer
- 17 when the motor vehicle or trailer has a later expiration date than
- 18 that chosen by the owner except as otherwise provided in sections
- 19 60-3,121 and 60-3,128 and section 3 of this act. Thereafter all
- 20 such motor vehicles or trailers shall be registered on an annual
- 21 basis starting in the month chosen by the owner.

ownership of any motor vehicle or trailer, (2) in case of loss 1 2 of possession because of fire, theft, dismantlement, or junking, 3 (3) when a salvage branded certificate of title is issued, (4) whenever a type or class of motor vehicle or trailer previously 4 5 registered is subsequently declared by legislative act or court 6 decision to be illegal or ineligible to be operated or towed on the public roads and no longer subject to registration fees, the motor vehicle tax imposed in section 60-3,185, and the motor vehicle 9 fee imposed in section 60-3,190, or (5) in case of a change in 10 the situs of a motor vehicle or trailer to a location outside of 11 this state, the registration shall expire and the registered owner 12 may, by returning the registration certificate, the license plates, 13 and, when appropriate, the validation decals and by either making 14 affidavit to the county treasurer or designated county official of 15 the occurrence of an event described in subdivisions (1) through 16 (4) of this section or, in the case of a change in situs, 17 displaying to the county treasurer or designated county official the registration certificate of such other state as evidence of a 18 19 change in situs, receive a refund of that part of the unused fees 20 on motor vehicles or trailers based on the number of unexpired 21 months remaining in the registration period from the date of the 22 event, except that when such date falls within the same calendar 23 month in which the motor vehicle or trailer is acquired, no refund 24 shall be allowed for such month. The registered owner shall make 25 a claim for credit or refund of the unused fees within sixty days

1 after the date of the event or shall be deemed to have forfeited

- 2 his or her right to such refund. For purposes of this section, the
- 3 date of the event shall be, in the case of a transfer or loss,
- 4 the date of the transfer or loss, in the case of a change in the
- 5 situs, the date of registration in another state, in the case of
- 6 a legislative act, the effective date of the act, and in the case
- 7 of a court decision, the date the decision is rendered. Application
- 8 for registration or for reassignment of license plates and, when
- 9 appropriate, validation decals to another motor vehicle or trailer
- 10 shall be made within thirty days of the date of purchase.

- 13 60-396 Whenever the registered owner files an application
- 14 with the county treasurer or designated county official showing
- 15 that a motor vehicle or trailer is disabled and has been

- 18 appropriate, the validation decals or, in the case of the
- 19 unavailability of such registration certificate or certificates,
- 20 license plates, or validation decals, then by making an affidavit
- 21 to the county treasurer or designated county official of such

- 24 State Treasurer at the time of registration based upon the number
- 25 of unexpired months remaining in the registration year except as

The owner shall also receive a credit for the unused 3 portion of the motor vehicle tax and fee based upon the number of unexpired months remaining in the registration year. When the 5 owner registers a replacement motor vehicle or trailer at the time of filing such affidavit, the credit may be immediately applied 6 7 against the registration fee and the motor vehicle tax and fee for 8 the replacement motor vehicle or trailer. When no such replacement 9 motor vehicle or trailer is so registered, the county treasurer 10 or designated county official shall forward the application and 11 affidavit, if any, to the State Treasurer who shall determine the 12 amount, if any, of the allowable credit for the registration fee 13 and issue a credit certificate to the owner. For the motor vehicle 14 tax and fee, the county treasurer or designated county official 15 shall determine the amount, if any, of the allowable credit and issue a credit certificate to the owner. When such motor vehicle 16 17 or trailer is removed from service within the same month in which 18 it was registered, no credits shall be allowed for such month. The credits may be applied against taxes and fees for new or 19 20 replacement motor vehicles or trailers incurred within one year 21 after cancellation of registration of the motor vehicle or trailer 22 for which the credits were allowed. When any such motor vehicle or 23 trailer is reregistered within the same registration year in which its registration has been canceled, the taxes and fees shall be 24 25 that portion of the registration fee and the motor vehicle tax and
