A BILL

- FOR AN ACT relating to motor vehicle dealers; to amend section

 60-1411.01, Reissue Revised Statutes of Nebraska, and

 section 60-1419, Revised Statutes Cumulative Supplement,

 2006; to increase licensing fees and a bond; and to

 repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-1411.01, Reissue Revised Statutes

- 2 of Nebraska, is amended to read:
- 3 60-1411.01 (1) To Until January 1, 2008, to pay the
- 4 expenses of the administration, operation, maintenance, and
- 5 enforcement of sections 60-1401.01 to 60-1440, the board shall
- 6 collect with each application for each class of license fees not
- 7 exceeding the following amounts:
- 8 (a) Motor vehicle dealer's license, two hundred dollars;
- 9 (b) Supplemental motor vehicle dealer's license, ten
- 10 dollars;
- 11 (c) Motor vehicle or motorcycle salesperson's license,
- 12 ten dollars;
- 13 (d) Dealer's agent license, fifty dollars;
- 14 (e) Motor vehicle, motorcycle, or trailer manufacturer's
- 15 license, three hundred dollars;
- 16 (f) Distributor's license, three hundred dollars;
- 17 (g) Factory representative's license, ten dollars;
- 18 (h) Distributor representative's license, ten dollars;
- 19 (i) Finance company's license, two hundred dollars;
- 20 (j) Wrecker or salvage dealer's license, one hundred
- 21 dollars;
- 22 (k) Factory branch license, one hundred dollars;
- 23 (1) Motorcycle dealer's license, two hundred dollars;
- 24 (m) Motor vehicle auction dealer's license, two hundred
- 25 dollars; and

1	(n) Trailer dealer's license, two hundred dollars.
2	(2) On and after January 1, 2008, to pay the expenses
3	of the administration, operation, maintenance, and enforcement of
4	sections 60-1401.01 to 60-1440, the board shall collect with each
5	application for each class of license fees not exceeding the
6	following amounts:
7	(a) Motor vehicle dealer's license, four hundred dollars;
8	(b) Supplemental motor vehicle dealer's license, twenty

10	(c) Motor vehicle or motorcycle salesperson's license,
11	<pre>twenty dollars;</pre>
12	(d) Dealer's agent license, one hundred dollars;
13	(e) Motor vehicle, motorcycle, or trailer manufacturer's

15	(f) Distributor's license, six hundred dollars;
16	(g) Factory representative's license, twenty dollars;
17	(h) Distributor representative's license, twenty dollars;

1 (2) (3) The fees shall be fixed by the board and

- 2 shall not exceed the amount actually necessary to sustain the
- 3 administration, operation, maintenance, and enforcement of sections
- 4 60-1401.01 to 60-1440.
- 5 (3) (4) Such licenses, if issued, shall expire on
- 6 December 31 next following the date of the issuance thereof.
- 7 Any motor vehicle, motorcycle, or trailer dealer changing its
- 8 location shall not be required to obtain a new license if the new
- 9 location is within the same city limits or county, all requirements
- 10 of law are complied with, and a fee of twenty-five dollars is
- 11 paid, but any change of ownership of any licensee shall require
- 12 a new application for a license and a new license. Change of
- 13 name of licensee without change of ownership shall require the
- 14 licensee to obtain a new license and pay a fee of five dollars.
- 15 Applications shall be made each year for a new or renewal license.
- 16 If the applicant is an individual, the application shall include
- 17 the applicant's social security number.
- 18 Sec. 2. Section 60-1419, Revised Statutes Cumulative
- 19 Supplement, 2006, is amended to read:
- 20 60-1419 (1) Applicants for a motor vehicle dealer's
- 21 license, trailer dealer's license, or motorcycle dealer's license
- 22 shall furnish, at the time of making application, furnish a
- 23 corporate surety bond in the penal sum of twenty thousand dollars,
- 24 but for the year 1985 and thereafter shall, at the time of making
- 25 application, furnish a corporate surety bond in the penal sum of

1 twenty-five fifty thousand dollars.

2 (2) Applicants for a motor vehicle auction dealer's 3 license shall, at the time of making application, furnish a corporate surety bond in the penal sum of not less than one hundred 4 5 thousand dollars. The bond shall be on a form prescribed by the Attorney General of the State of Nebraska and shall be signed 6 7 by the Nebraska registered agent. The bond shall provide: (1) 8 (a) That the applicant will faithfully perform all the terms and 9 conditions of such license; (2) (b) that the licensed dealer will 10 first fully indemnify any holder of a lien or security interest 11 created pursuant to section 60-164 or article 9, Uniform Commercial 12 Code, whichever applies, in the order of its priority and then any person or other dealer by reason of any loss suffered because of 13 14 (a) (i) the substitution of any motor vehicle or trailer other than 15 the one selected by the purchaser, (b) (ii) the dealer's failure 16 to deliver to the purchaser a clear and marketable title, (c) 17 (iii) the dealer's misappropriation of any funds belonging to the 18 purchaser, (d) (iv) any alteration on the part of the dealer so as 19 to deceive the purchaser as to the year model of any motor vehicle 20 or trailer, (e) (v) any false and fraudulent representations or 21 deceitful practices whatever in representing any motor vehicle or 22 trailer, (f) (vi) the dealer's failure to remit the proceeds from the sale of any motor vehicle which is subject to a lien or 23 24 security interest to the holder of such lien or security interest, 25 and (g) (vii) the dealer's failure to pay any person or other

1 dealer for the purchase of a motor vehicle, motorcycle, trailer,

- 2 or any part or other purchase; and (3) (c) that the motor vehicle,
- 3 motorcycle, motor vehicle auction, or trailer dealer or wholesaler
- 4 shall well, truly, and faithfully comply with all the provisions of
- 5 his or her license and the acts of the Legislature relating to such
- 6 license. The aggregate liability of the surety shall in no event
- 7 exceed the penalty of such bond.
