The Director of Administrative Services is hereby 6 authorized and directed to draw his or her warrants on or before 7 June 30, 2007, upon the funds in the state treasury enumerated 8 in this act, in favor of the several beneficiaries named in 9 this act for the amount set opposite their respective names upon 10 the presentation of proper vouchers therefor. The several amounts 11 appropriated in this act shall be in full payment of any and all 12 claims, rights, causes of action, damages, and demands of every 13 character and kind owing by or against the State of Nebraska, its 14 officers, agents, and employees, and their successors and assigns 15 with respect to each of the beneficiaries respectively in whose 16 favor the appropriations are made. The director shall not deliver 17 any warrant for any items appropriated in this act until a receipt 18 and release in full, releasing the State of Nebraska, its officers, 19 employees, and agents, and their successors and assigns, has been 20 filed by each of the beneficiaries respectively. Upon presentation of the warrants, the State Treasurer is hereby directed to pay the 21 22 same out of money in the General Fund or out of money in other 23 funds indicated in this act not otherwise appropriated.
