LB259 changes provisions relating to the deposit of public funds. Provisions of current law require public fund deposits in excess of amounts insured by the Federal Deposit Insurance Corporation (FDIC) to be secured either by pledged securities or a guarantee bond. The bill would modify the requirement so as to provide that public fund deposits in excess of amounts insured or guaranteed by the FDIC would be required to be secured. To the extent FDIC-guaranteed public fund deposits represent no greater risk of loss than FDIC-insured public fund deposits, the bill would represent no fiscal implications with respect to security of deposited public funds.
