- 23 license plate when it is designed. The department shall not
- 24 manufacture specialty license plates for an organization until

- 21 (e) Five hundred prepaid applications for the speciality
- 22 license plates; and
- 23 (f) A completed application for the issuance of the
- 24 plates on a form provided by the department certifying that the
- 25 organization meets the following requirements:

1 (i) The organization is a nonprofit corporation or a

- 2 group of nonprofit corporations with a common purpose;
- 3 (ii) The primary activity or purpose of the organization
- 4 serves the community, contributes to the welfare of others, and is

- 13 will result from such use of such name, logo, or graphic design;

- 16 Nebraska and its employees and agents for any liability which may
- 17 result from any infringement or violation of a property right based
- 18 on the use of such name, logo, or graphic design.

- 20 Any money in the fund available for investment shall be invested
- 21 by the state investment officer pursuant to the Nebraska Capital
- 22 Expansion Act and the Nebraska State Funds Investment Act.
- 23 (2) If the cost of manufacturing Nebraska Cornhusker
- 24 Spirit Plates at any time exceeds the amount charged for license
- 25 plates pursuant to section 60-3,102, any money to be credited to

1 the Spirit Plate Proceeds Fund shall instead be credited first

- 2 to the Highway Trust Fund in an amount equal to the difference
- 3 between the manufacturing costs of such spirit plates and the
