1 Section 1. Section 28-718, Reissue Revised Statutes of

- 3 28-718 There shall be a central register of child
- 4 protection cases maintained in the department containing records
- 5 of all reports of child abuse or neglect opened for investigation
- 6 as provided in section 28-713 and classified as either court
- 7 substantiated or inconclusive agency substantiated as provided in
- 8 section 28-720. The department may change records classified as
- 9 inconclusive prior to the effective date of this act to agency
- 10 substantiated. The department shall give public notice of the
- 11 changes made to this section and subsection (3) of section 28-720
- 12 by this legislative bill within thirty days after the effective
- 13 date of this act by having such notice published in a newspaper or
- 14 newspapers of general circulation within the state.

- 22 of the report of child abuse or neglect upon a criminal complaint,
- 23 indictment, or information or there has been an adjudication of
- 24 jurisdiction of a juvenile court over the child under subdivision
- 25 (3)(a) of section 43-247 which relates or pertains to the report

- 2 (2) Court pending, if a criminal complaint, indictment,
- 3 or information or a juvenile petition under subdivision (3)(a) of

- 6 court of competent jurisdiction; or
- 7 (3) Inconclusive, Agency substantiated, if the
- 8 department's determination of child abuse or neglect against the
- 9 subject of the report of child abuse or neglect was made, supported
- 10 by a preponderance of the evidence, and based upon an investigation
- 11 pursuant to section 28-713.
