A BILL

- FOR AN ACT relating to hearing interpreters; to amend section
- 2 20-156, Reissue Revised Statutes of Nebraska; to change
- 3 provisions relating to fees; and to repeal the original
- 4 section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 20-156, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 20-156 (1) The Commission for the Deaf and Hard of
- 4 Hearing shall license and evaluate licensed interpreters. The
- 5 commission shall create the Interpreter Review Board pursuant
- 6 to section 71-4728.05 to set policies, standards, and procedures
- 7 for evaluation and licensing of interpreters. The commission may
- 8 recognize evaluation and certification programs as a means to carry
- 9 out the duty of evaluating interpreters' skills. The commission
- 10 may define and establish different levels or types of licensure
- 11 to reflect different levels of proficiency and different specialty
- 12 areas.
- 13 (2) The commission shall establish and charge reasonable
- 14 fees for licensure of interpreters, including applications, initial
- 15 competency assessments, renewals, modifications, record keeping,
- 16 approval, conduct, and sponsorship of continuing education, and
- 17 assessment of continuing competency pursuant to sections 20-150
- 18 to 20-159. All fees collected pursuant to this section by the
- 19 commission shall be remitted to the State Treasurer for credit to
- 20 the Commission for the Deaf and Hard of Hearing Fund. Such fees
- 21 shall be disbursed for payment of expenses related to this section.
- 22 (3) The commission shall prepare and maintain a roster
- 23 of licensed interpreters as provided by section 71-4728. Nothing
- 24 in sections 20-150 to 20-159 shall be construed to prevent any
- 25 appointing authority from contracting with a licensed interpreter

- 1 on a full-time employment basis.
- 2 (4) The commission may deny, refuse to renew, limit,
- 3 revoke, suspend, or take other disciplinary actions against a
- 4 license when the applicant or licensee is found to have violated
- 5 any provision of sections 20-150 to 20-159 or 71-4728 to 71-4732,
- 6 or any rule or regulation of the commission adopted and promulgated
- 7 pursuant to such sections, including rules and regulations
- 8 governing unprofessional conduct. The Interpreter Review Board
- 9 shall investigate complaints regarding the use of interpreters
- 10 by any appointing authority, or the providing of interpreting
- 11 services by any interpreter, alleged to be in violation of sections
- 12 20-150 to 20-159 or rules and regulations of the commission.
- 13 The commission shall notify in writing an appointing authority
- 14 determined to be employing interpreters in violation of sections
- 15 20-150 to 20-159 or rules and regulations of the commission
- 16 and shall monitor such appointing authority to prevent future
- 17 violations.
- 18 (5) Any decision of the commission pursuant to this
- 19 section shall be subject to review according to the Administrative
- 20 Procedure Act.
- 21 (6) After June 30, 2007, any person providing
- 22 interpreting services pursuant to sections 20-150 to 20-159 without
- 23 a license issued pursuant to this section may be restrained by
- 24 temporary and permanent injunctions.
