A BILL

- 1 FOR AN ACT relating to the Telecommunications Relay System Act;
- 2 to amend section 86-313, Reissue Revised Statutes of
- 3 Nebraska; to change surcharge remittance requirements;
- 4 and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 86-313, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 86-313 (1)(a) Each telephone company in Nebraska shall
- 4 collect from each of the telephone subscribers a surcharge not
- 5 to exceed twenty cents per month on each telephone number or
- 6 functional equivalent in Nebraska, including wireless service as
- 7 defined in section 86-456.01. Except for wireless service, the
- 8 surcharge shall only be collected on the first one hundred
- 9 telephone numbers or functional equivalents per subscriber. The
- 10 companies shall add the surcharge to each subscriber's bill.
- 11 (b) The telephone companies are not liable for any
- 12 surcharge not paid by a subscriber.
- 13 (2) Before April 1 of each year, the commission shall
- 14 hold a public hearing to determine the amount of surcharge
- 15 necessary to carry out the Telecommunications Relay System Act.
- 16 After the hearing, the commission shall set the surcharge at the
- 17 level necessary to fund the statewide telecommunications relay
- 18 system and the specialized telecommunications equipment program for
- 19 the following year plus a reasonable reserve. The surcharge shall
- 20 become effective on July 1 following the change.
- 21 (3) In an emergency the commission may adjust the amount
- 22 of the surcharge to become effective before such date but only
- 23 after a public hearing for such purpose.
- 24 (4) The Each telephone company shall remit the proceeds
- 25 from the surcharge shall be remitted to the commission. monthly no

1 later than thirty days after the end of the month in which they

- 2 were collected together with forms provided by the commission. The
- 3 commission shall remit the funds to the State Treasurer for credit
- 4 to the fund.
- 5 (5) The commission may require an audit of any company
- 6 collecting the surcharge pursuant to the act.
- 7 (6) This section shall not apply to subscribers who have
- 8 no access to relay service.

- 10 of Nebraska, is repealed.
