- 20 (2) The department shall make applications available
- 21 pursuant to section 3 of this act for each type of specialty
- 22 license plate when it is designed. The department shall not
- 23 manufacture specialty license plates for an organization until
- 24 the department has received one hundred fifty prepaid applications
- 25 for specialty license plates designed for that organization. The

1 department may revoke the approval for an organization's specialty

- 2 license plate if the total number of registered vehicles that

- 18 (d) A copy of a certificate of existence on file with the
- 19 Secretary of State under the Nebraska Nonprofit Corporation Act;
- 20 (e) One hundred fifty prepaid applications for the
- 21 speciality license plates; and
- 22 (f) A completed application for the issuance of the
- 23 plates on a form provided by the department certifying that the
- 24 <u>organization meets the following requirements:</u>
- 25 (i) The organization is a nonprofit corporation or a

- 1 group of nonprofit corporations with a common purpose;
- 2 (ii) The primary activity or purpose of the organization
- 3 serves the community, contributes to the welfare of others, and is
- 4 not offensive or discriminatory in its purpose, nature, activity,
- 5 or name;
- 6 (iii) The name and purpose of the organization does not
- 7 promote any specific product or brand name that is on a product
- 8 provided for sale;
- 9 (iv) The purpose of the organization does not promote a
- 10 specific religion, faith, or anti-religious belief;
- 11 (v) The organization is authorized to use any name, logo,
- 12 or graphic design suggested for the design of the plates;
- 13 (vi) No infringement or violation of any property right
- 14 will result from such use of such name, logo, or graphic design;
- 15 and
- 16 (vii) The organization will hold harmless the State of
- 17 Nebraska and its employees and agents for any liability which may
- 18 result from any infringement or violation of a property right based
- 19 on the use of such name, logo, or graphic design.
- 20 (4) The department may adopt and promulgate rules and
- 21 regulations to carry out this section.
