- 1 FOR AN ACT relating to the Medicine and Surgery Practice Act;
 2 to amend section 38-2001, Reissue Revised Statutes of

 4 to define terms relating to unprofessional conduct; to
 5 harmonize provisions; to provide an operative date; and
 6 to repeal the original section.

- 4 act shall be known and may be cited as the Medicine and Surgery

- 6 Sec. 2. (1) It shall be unprofessional conduct for any
- 7 physician who orders but does not supervise or perform a component
- 8 of an anatomic pathology service to fail to disclose in any bill
- 9 for such service presented to a patient, entity, or person:
- 10 (a) The name and address of the physician or laboratory
- 11 that provided the anatomic service; and
- 12 (b) The actual amount paid or to be paid for each
- 13 anatomic pathology service provided to the patient by the physician
- 14 or laboratory that performed the service.
- 15 (2) For purposes of this section, anatomic pathology
- 16 service means:
- 17 (a) Blood-banking services performed by pathologists;
- 18 (b) Cytopathology, which means the microscopic
- 19 examination of cells from the following: Fluids; aspirates;
- 20 washings; brushings; or smears, including the Pap test examination
- 21 performed by a physician or under the supervision of a physician;
- 22 (c) Hematology, which means the microscopic evaluation
- 23 of bone marrow aspirates and biopsies performed by a physician or
- 24 under the supervision of a physician and peripheral blood smears
- 25 when the attending or treating physician or technologist requests

- that a blood smear be reviewed by the pathologist;
- 2 (d) Histopathology or surgical pathology, which means
- 3 the gross and microscopic examination and histologic processing of
- 4 organ tissue performed by a physician or under the supervision of
- 5 a physician; and
- 6 (e) Subcellular pathology and molecular pathology.
- 7 (3) For purposes of this section, anatomic pathology
- 8 service does not include the initial collection or packaging of the
- 9 specimen for transport.
- 10 Sec. 3. This act becomes operative on January 1, 2010.
- 11 Sec. 4. Original section 38-2001, Reissue Revised
- 12 Statutes of Nebraska, is repealed.
