#### A BILL

- FOR AN ACT relating to the Nebraska State Capitol Environs

  District; to amend section 90-303, Reissue Revised

  Statutes of Nebraska; to change a height restriction within the district; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 90-303, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 90-303 (1) The maximum height of any buildings and
- 4 structures built after March 8, 1977, shall be restricted as
- 5 follows:
- 6 (a) The maximum height of buildings and structures shall
- 7 be forty-five feet or National Geodetic Survey elevation 1235.0
- 8 feet, whichever is lower, within an area bounded on the west by
- 9 Seventeenth Street, on the north by K Street, on the east by a
- 10 boundary formed by a line extending in a true south direction as
- 11 an extension of the east property line of Twenty-fourth Street, and
- 12 on the south by a boundary formed by a line extending directly in
- 13 a true east direction to the east property line of Twenty-fourth
- 14 Street from the centerpoint of the intersection of Seventeenth and
- 15 H Streets, all streets in the city of Lincoln, Lancaster County,
- 16 Nebraska;
- 17 (b) The maximum height of buildings and structures shall
- 18 be forty-five feet or National Geodetic Survey elevation 1235.0
- 19 feet, whichever is lower, within an area bounded on the west
- 20 by Fourteenth Street, on the north by G Street, on the east
- 21 by Sixteenth Street, and on the south by Washington Street, all
- 22 streets in the city of Lincoln, Lancaster County, Nebraska;
- 23 (c) The maximum height of the buildings and structures
- 24 shall be fifty-seven feet or National Geodetic Survey elevation
- 25 1247.0 feet, whichever is lower, within an area bounded on the west

- 3 the city of Lincoln, Lancaster County, Nebraska;
- 4 (d) The maximum height of the buildings and structures
- 5 shall be fifty-seven feet or National Geodetic Survey elevation
- 6 1247.0 feet, whichever is lower, within an area bounded on the west
- 7 by Fourteenth Street, on the north by S Street, on the east by
- 8 Sixteenth Street, and on the south by L Street, all streets in the
- 9 city of Lincoln, Lancaster County, Nebraska; and
- 10 (e) The maximum height of the buildings and structures
- 11 shall be fifty-seven feet or National Geodetic Survey elevation
- 12 1247.0 feet, whichever is lower, within an area bounded on the west
- 13 by Tenth Fifth Street, on the north by K Street, on the east by
- 14 Thirteenth Street, and on the south by H Street, all streets in the
- 15 city of Lincoln, Lancaster County, Nebraska.
- 16 (2) For the purposes of the Nebraska State Capitol
- 17 Environs Act, the areas and the full width of the right-of-way
- 18 boundary streets described in subsections (1) and (3) of this
- 19 section shall together constitute and be defined as the Nebraska
- 20 State Capitol Environs District.
- 21 (3) Design approval shall be required for all aboveground
- 22 utility, construction, and landscape improvements in the public
- 23 right-of-way bounded on the north and south by the property lines
- 24 of J Street, on the west by a boundary formed by a line extending
- 25 in a true south direction as an extension of the east property line

1 of Twenty-fourth Street, and on the east by a line extending in a

- 2 true north direction as an extension of the east property line of
- 3 Thirty-fifth Street.
- 4 (4) The city of Lincoln shall insure, through its
- 5 inspection and permit procedures, that the maximum height
- 6 restrictions and design review process prescribed by this section
- 7 for the Nebraska State Capitol Environs District are enforced.
- 8 (5) The height restrictions and design review process
- 9 required by this section shall apply, within the Nebraska State
- 10 Capitol Environs District, to all real estate in private or
- 11 quasi-public ownership and to real estate owned by the State of
- 12 Nebraska and local governmental units of all types.
- 13 (6) The following appurtenances shall be exempt from
- 14 the height restrictions required by this section, but such
- 15 appurtenances shall not exceed twenty feet in height above the
- 16 maximum height permitted in subsection (1) of this section and
- 17 shall be set back a minimum of fifteen feet from all faces of
- 18 a building when such faces are adjacent to a street: Church
- 19 spires, cooling towers with approved screening, elevator bulkheads,
- 20 fire towers, monuments, stage towers or scenery lofts, ornamental
- 21 towers, and spires.
- 22 (7) Nothing in the act shall be construed as limiting
- 23 the authority of the city of Lincoln to impose lower height
- 24 restrictions than those maximum height limits established by
- 25 subsection (1) of this section or in establishing lower height

1 restrictions for appurtenances than those required by subsection

- 2 (6) of this section.
- 3 (8) The city of Lincoln shall review and approve or
- 4 disapprove plans and proposals for demolition, exterior alteration,
- 5 and construction of structures and other improvements in the
- 6 Nebraska State Capitol Environs District. The city of Lincoln shall
- 7 adopt regulations within its zoning code vesting responsibility for
- 8 review, approval, and disapproval of projects with the Nebraska
- 9 State Capitol Environs Commission established by the city of
- 10 Lincoln.
- 11 (9) The regulations of the city of Lincoln for design
- 12 review in the Nebraska State Capitol Environs District shall
- 13 emphasize the long-term enhancement of the State Capitol's setting
- 14 and of enjoyment of the State Capitol by the citizens while
- 15 respecting the interests of property owners, including economic
- 16 interests and the desirability of predictable, expeditious review.

- 18 of Nebraska, is repealed.
