A BILL

1	FOR	AN	ACT relating to the Nebraska Real Estate License Act;
2			to amend section 81-885.03, Reissue Revised Statutes
3			of Nebraska, and sections 81-885.10, 81-885.25, and
4			81-885.29, Revised Statutes Supplement, 2009; to provide
5			for jurisdiction and the issuance of cease and desist
6			orders as prescribed; to provide for fines; to harmonize
7			provisions; and to repeal the original sections.

8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-885.03, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 81-885.03 (1) Any person who, directly or indirectly for
- 4 another, with the intention or upon the promise of receiving any
- 5 form of compensation or consideration, offers, attempts, or agrees
- 6 to perform or performs any single act described in subdivision (2)
- 7 of section 81-885.01, whether as a part of a transaction, or as an
- 8 entire transaction, shall be deemed a broker, associate broker, or
- 9 salesperson within the meaning of the Nebraska Real Estate License
- 10 Act, and such action shall constitute sufficient contact with the
- 11 state for the exercise of personal jurisdiction over such person
- 12 in any action arising out of such action. Committing a single act
- 13 described in such subdivision by a person required to be licensed
- 14 under the Nebraska Real Estate License Act and not so licensed
- 15 shall constitute a violation of the act for which the commission
- 16 may impose sanctions pursuant to this section for the protection of
- 17 the public health, safety, or welfare.
- 18 (2) Notwithstanding any other provision of the law to the
- 19 contrary, the director may issue a cease and desist order against
- 20 any person who violates this section by performing any action
- 21 described in subsection (1) of this section without the appropriate
- 22 license. Such order shall be final ten days after issuance unless
- 23 the violator requests a hearing pursuant to section 81-885.25.
- 24 (3) If such person violates a cease and desist order
- 25 <u>issued pursuant to this section, he or she shall be subject</u>

1 to further proceedings before the commission. If, during such

- 2 proceedings, the commission makes a finding of guilt, the
- 3 commission may impose a fine not to exceed (a) one thousand dollars
- 4 for each day that any action is performed without the appropriate
- 5 license following the issuance of the order or (b) the amount
- 6 of all money earned as commission by the violator, whichever is
- 7 greater. Judgments for the collection of any fine imposed under
- 8 this section may be filed in the district court of any county in
- 9 this state.
- 10 (4) Notice and hearing requirements under this section
- 11 shall be in accordance with the Administrative Procedure Act.
- 12 Sec. 2. Section 81-885.10, Revised Statutes Supplement,
- 13 2009, is amended to read:
- 14 81-885.10 The commission shall have the full power to
- 15 regulate the issuance of licenses and the activities of licensees
- 16 and to and may impose sanctions pursuant to this section for the
- 17 protection of the public health, safety, or welfare. The commission
- 18 may revoke or suspend licenses issued under the Nebraska Real
- 19 Estate License Act, to censure licensees, and to enter into consent
- 20 decrees, and issue cease and desist orders to violators of section
- 21 81-885.03. The commission may, alone or in combination with such
- 22 disciplinary actions, impose a civil fine on a licensee for each
- 23 violation alleged in a complaint for which the commission has made
- 24 a finding of quilt, except that the total fine for such violations
- 25 shall not exceed two thousand five hundred dollars per complaint.

1 The commission may also impose a civil fine on violators of section

- 2 81-885.03 subject to the limits in such section.
- 3 The commission shall retain its powers under this section
- 4 with respect to the actions of a licensee, whether or not he or she
- 5 continues to be licensed under the act.
- 6 Sec. 3. Section 81-885.25, Revised Statutes Supplement,
- 7 2009, is amended to read:
- 8 81-885.25 (1) Before the commission censures a licensee,
- 9 imposes a civil fine, or revokes or suspends a license, or issues a
- 10 cease and desist order, the commission shall send to the licensee
- 11 or violator a copy of the complaint by certified mail which
- 12 contains the charges against the licensee or violator and, unless
- 13 the licensee or violator waives the right to a hearing and has
- 14 executed a consent order, give the licensee or violator a hearing
- 15 on the matter.
- 16 (2) The license holder licensee or violator shall have
- 17 full authority to be heard in person or by counsel before the
- 18 commission in reference to such charges. The commission shall, at
- 19 least twenty days prior to the date set for hearing, notify the
- 20 licensee or violator in writing of the date and place of the
- 21 hearing. Such notice may be served by delivering it personally
- 22 to the license holder licensee or violator or by sending it by
- 23 either registered or certified mail to the last-known business
- 24 address of such license holder licensee or any known address of
- 25 the violator. If the license holder licensee is an associate broker

1 or a salesperson, the commission shall also notify the broker

- 2 employing the license holder licensee by mailing a copy of such
- 3 notice to the broker's last-known business address.
- 4 Sec. 4. Section 81-885.29, Revised Statutes Supplement,
- 5 2009, is amended to read:
- 6 81-885.29 After the hearing the commission shall state
- 7 in writing, officially signed by the chairperson and attested to
- 8 by the director, its findings and determination and its order
- 9 in the matter. If the commission determines that the license
- 10 holder licensee has been guilty of any violation of the Nebraska
- 11 Real Estate License Act or the rules and regulations of the
- 12 commission or the violator has been guilty of a violation of
- 13 section 81-885.03, the commission may revoke or suspend the
- 14 license, enter an order censuring the license holder, licensee,
- 15 or impose a civil fine on a licensee pursuant to section 81-885.10
- 16 or on a violator pursuant to section 81-885.03. The execution of
- 17 a penalty of suspension may be stayed by the commission and the
- 18 licensee may be placed on probation for the suspension period,
- 19 after satisfactory completion of which his or her license shall
- 20 be fully reinstated. Any violation of the act or the rules and
- 21 regulations by the licensee during the period of probation shall
- 22 cause the immediate execution of the suspension penalty.
