- FOR AN ACT relating to the Nebraska Liquor Control Act; to amend section 53-149, Reissue Revised Statutes of Nebraska; to provide for a temporary operating permit; and to repeal the original section.

1 Section 1. Section 53-149, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 53-149 (1) A license shall be purely a personal
- 4 privilege, good for not to exceed one year after issuance unless
- 5 sooner revoked as provided in the Nebraska Liquor Control Act,
- 6 and shall not constitute property, nor shall it be subject to
- 7 attachment, garnishment, or execution, nor shall it be alienable
- 8 or transferable, voluntarily or involuntarily, or subject to being
- 9 encumbered or hypothecated.
- 10 (2) A license issued under the act terminates immediately
- 11 upon the sale of the licensed premises named in such license.
- 12 The purchaser or transferee may submit an application for a
- 13 license under the act prior to closing such sale or transfer.
- 14 While such application is pending, the purchaser may request and
- 15 obtain a temporary operating permit from the commission which
- 16 shall authorize the purchaser to continue the business which was
- 17 conducted on the purchased premises under the terms and conditions
- 18 of the terminated license for ninety days or until the purchaser
- 19 has obtained a license in its own name, whichever occurs sooner.
- 20 In the absence of such temporary operating permit, the purchaser
- 21 shall not manufacture, store, or sell alcoholic liquor on the
- 22 purchased premises until the purchaser has obtained a license in
- 23 the purchaser's own name.
- 24 Such (3) A license shall not descend by the laws of
- 25 testate or intestate devolution, but it shall cease upon the death

of the licensee, except that (1) (a) executors or administrators 1 2 of the estate of any deceased licensee, when such estate consists 3 in part of alcoholic liquor, or a partnership or limited liability company upon the death of one or more of the partners or members, 4 5 may continue the business of the sale or manufacture of alcoholic <u>liquor</u> under order of the appropriate court and may exercise the 6 7 privileges of the deceased or deceased partner or member after the death of such decedent until the expiration of such license, 9 but if such license would have expired within two months following 10 the death of the licensee, the license may be renewed by the 11 administrators or executors with the approval of the appropriate 12 court for a period not to exceed one additional year; or (2) (b) 13 when a license is issued to a husband and wife, as colicensees with 14 rights of survivorship, upon the death of one spouse the survivor 15 may exercise all rights and privileges under such license in his or 16 her own name. The trustee of any insolvent or bankrupt licensee, 17 when such estate consists in part of alcoholic liquor, may continue 18 the business of the sale or manufacture of alcoholic liquor under order of the appropriate court and may exercise the privileges of 19 20 the insolvent or bankrupt licensee until the expiration of such 21 license.
