LB 262 amends Nebraska Statutes Sections 44-3,158 and 48-144.03 to remove the requirement that an employer establish safety committees pursuant to Sections 48-443 to 48-445.

The bill also outright repeals the following 44 sections of statute dealing with various safety requirements. In most cases, these sections have either become obsolete or are covered under OSHA.

- Sec. 48-401 Water closets; employer duty to provide
- Sec. 48-402 Dressing rooms; duty to provide
- Sec. 48-403 Ventilation; dust and fumes, fans required
- Sec. 48-404 Sanitation; duty of employer
- Sec. 48-405 Grinding machines; dust; blowers required
- Sec. 48-406 Emery wheels and grindstones; use and operation
- Sec. 48-407 Emery wheels and grindstones; hood or hoppers required
- Sec. 48-408 Emery wheels; suction pipes required; capacity

The bill also repeals Section 48-446. This section created the Workplace Safety Consultation Program and the Workplace Safety Cash Fund and provides duties for the Department of Labor.
