This bill would adopt the Nebraska Uniform Adult Guardianship and Protective Proceedings Jurisdiction Act.

The Supreme Court estimates a one-time cash fund expenditure of \$5,000 for training. Their response follows:

LB 85 would establish new procedures regarding adult guardianships from jurisdictions outside Nebraska. Although, based on the volume of guardianships and proceedings brought under this Act, judicial resources and workload could be affected, the impact is not estimated to be significant. Cash fund expenditures from the Supreme Court Education Fund for training for all judges and court staff on new procedures is estimated at \$5,000.
