A BILL

FOR AN ACT relating to the Nebraska Rules of the Road; to amend
sections 60-601 and 60-6,291, Reissue Revised Statutes of
Nebraska; to provide notification requirements prior to
moving a building or object over a certain height or
width; to provide a penalty; to harmonize provisions; and
to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-601, Reissue Revised Statutes of

- 3 60-601 Sections 60-601 to 60-6,379 <u>and section 2 of this</u>
- 4 act shall be known and may be cited as the Nebraska Rules of the
- 5 Road.
- 6 Sec. 2. Any person moving a building or an object that,
- 7 in combination with the transporting vehicle, is over fifteen feet,
- 8 six inches high or wider than the roadway on a county or township
- 9 road shall notify the local authority and the electric utility
- 10 responsible for the infrastructure, including poles, wires,
- 11 substations, and underground residential distribution cable boxes
- 12 adjacent to or crossing the roadway along the route over which such
- 13 building or object is being transported. Notification shall be made
- 14 at least ten days prior to the move. Notification shall specifically
- 15 describe the transporting vehicle, the width, length, height, and
- 16 weight of the building or object to be moved, the route to be used,
- 17 and the date and hours during which the building or object will be
- 18 transported. Complying with the notification requirement of this
- 19 section does not exempt the person from complying with any other
- 20 <u>federal</u>, <u>state</u>, <u>or local authority permit or notification</u>
- 21 <u>requirements.</u>

- 2 highway any vehicle or vehicles which exceed the limitations as to
- 3 width, length, or height as provided in such sections for which a
- 4 penalty is not elsewhere provided shall be guilty of a Class III
- 5 misdemeanor.
