A BILL

FOR AN ACT relating to elections; to amend section 32-618, Reissue
Revised Statutes of Nebraska; to change the number of
signatures needed for nomination by petition in certain
partisan offices; to repeal the original section; and to
declare an emergency.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-618, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 32-618 (1) The number of signatures of registered voters
- 4 needed to place the name of a candidate upon the nonpartisan ballot
- 5 for the general election shall be as follows:
- 6 (a) For each nonpartisan office other than members of the
- 7 Board of Regents of the University of Nebraska and board members of a
- 8 Class III school district, at least ten percent of the total number
- 9 of registered voters voting for Governor or President of the United
- 10 States at the immediately preceding general election in the district
- 11 or political subdivision in which the officer is to be elected, not
- 12 to exceed two thousand; . If the district in which the petitions are
- 13 circulated comprises two or more counties, at least twenty-five
- 14 signatures shall be obtained in each county which has at least one
- 15 hundred registered voters in the district;
- 16 (b) For members of the Board of Regents of the University
- 17 of Nebraska, at least ten percent of the total number of registered
- 18 voters voting for Governor or President of the United States at the
- 19 immediately preceding general election in the regent district in
- 20 which the officer is to be elected, not to exceed one thousand; and -
- 21 If the regent district in which the petitions are circulated
- 22 comprises more than two counties, at least twenty-five signatures
- 23 shall be obtained in each of two-fifths of the counties comprising
- 24 the district; and
- 25 (c) For board members of a Class III school district, at

1 least twenty percent of the total number of votes cast for the board

- 2 member receiving the highest number of votes at the immediately
- 3 preceding general election in the school district.
- 4 (2) The number of signatures of registered voters needed
- 5 to place the name of a candidate upon the partisan ballot for the
- 6 general election shall be as follows:
- 7 (a) For each partisan office to be filled by the
- 8 registered voters of the entire state, at least four thousand, and at
- 9 least <u>seven hundred</u> fifty signatures shall be obtained in each of
- 10 one third of the counties congressional district in the state; and
- 11 (b) For each partisan office to be filled by the
- 12 registered voters of a county or political subdivision, at least
- 13 twenty percent of the total vote for Governor or President of the
- 14 United States at the immediately preceding general election within
- 15 the county or political subdivision, not to exceed two thousand.
- 16 The number of signatures shall not be required to exceed
- 17 one-fourth of the total number of registered voters voting for the
- 18 office at the immediately preceding general election when the
- 19 nomination is for a partisan office to be filled by the registered
- 20 voters of a county.
- 21 Sec. 2. Original section 32-618, Reissue Revised Statutes
- 22 of Nebraska, is repealed.
- Sec. 3. Since an emergency exists, this act takes effect
- 24 when passed and approved according to law.
