There is included in the appropriation to this program 14 for FY2011-12 a retainer fee of up to \$423,272 Cash Funds and for 15 FY2012-13 a retainer fee of up to \$423,272 Cash Funds which shall be 16 billed and paid in equal monthly installments to 17 the Intergovernmental Data Services Program Revolving Fund for county 18 automation expenses in lieu of standard central processing unit 19 20 charges, which shall only be used for such purpose. These retainer 21 fee amounts shall not include pass-through charges for leased computers and printers, software maintenance costs, or county data 22 conversion or interface costs. The annual retainer fee for both 23 FY2011-12 and FY2012-13 shall be paid prior to the end of each 24

1 respective fiscal year.

2 There is included in the appropriation to this program for FY2011-12 a retainer fee of \$4,170 Cash Funds which shall be paid 3 in four equal quarterly amounts to the Nebraska Public Safety 4 5 Communication System Revolving Fund on or before July 15, October 15, б January 15, and April 15 for Department of Administrative Services 7 central costs of operating the Nebraska Public Safety Communication 8 System, which shall only be used for such purpose. The retainer fee amounts shall only be expended against budget subprogram 1 as a 9 separate and distinct budget subprogram and shall not be commingled 10 11 with any other expenses.

12 There is included in the appropriation to this program 13 for FY2012-13 a retainer fee of \$4,170 Cash Funds which shall be paid 14 in four equal quarterly amounts to the Nebraska Public Safety 15 Communication System Revolving Fund on or before July 15, October 15, January 15, and April 15 for Department of Administrative Services 16 17 central costs of operating the Nebraska Public Safety Communication System, which shall only be used for such purpose. The retainer fee 18 amounts shall only be expended against budget subprogram 1 as a 19 20 separate and distinct budget subprogram and shall not be commingled with any other expenses. 21
