A BILL

FOR AN ACT relating to counties; to amend sections 16-731 and 23-1601, Reissue Revised Statutes of Nebraska; to change duties of county treasurers; to authorize the county treasurer to hold certain school district funds as prescribed; to harmonize provisions; and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 16-731, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 16-731 Any city of the first class may request that bond
- 4 fund money be included with payments distributed under subsection (3)
- 5 (4) of section 23-1601. Such bond fund money shall be included in the
- 6 monthly payment until notified otherwise by the city.
- 7 Sec. 2. Section 23-1601, Reissue Revised Statutes of
- 8 Nebraska, is amended to read:
- 9 23-1601 (1) It is the duty of the county treasurer to
- 10 receive all money belonging to the county, from whatsoever source
- 11 derived and by any method of payment provided by section 77-1702, and
- 12 all other money which is by law directed to be paid to him or her.
- 13 All money received by the county treasurer for the use of the county
- 14 shall be paid out by him or her only on warrants issued by the county
- 15 board according to law, except when special provision for payment of
- 16 county money is otherwise made by law.
- 17 (2) The county treasurer shall prepare and file the
- 18 required annual inventory statement of county personal property in
- 19 his or her custody or possession as provided in sections 23-346 to
- 20 23-350.
- 21 (3) The county treasurer, at the direction of the city or
- 22 village, shall invest the bond fund money collected for each city or
- 23 village located within each county. The bond fund money shall be
- 24 invested by the county treasurer and any investment income shall
- 25 accrue to the bond fund. The county treasurer shall notify the city

1 or village when the bonds have been retired.

- 2 (4)(a) On or before the fifteenth day of each month, the 3 county treasurer (i) shall pay to each city, village, school district, educational service unit, county agricultural society, and 4 5 rural or suburban fire protection district located within the county the amount of all funds collected or received for the city, village, 6 7 school district, educational service unit, county agricultural 8 society, and rural or suburban fire protection district the previous calendar month, including bond fund money when requested by any city 9 of the first class under section 16-731, and (ii) on forms provided 10 by the Auditor of Public Accounts, shall include with the payment a 11 12 statement indicating the source of all such funds received or 13 collected and an accounting of any expense incurred in the collection of ad valorem taxes, except that the Auditor of Public Accounts 14 15 shall, upon request of a county, approve the use and reproduction of a county's general ledger or other existing forms if such ledger or 16 other forms clearly indicate the sources of all funds received or 17 collected and an accounting of any expenses incurred in the 18 collection of ad valorem taxes. 19
- 20 (b) If all such funds received or collected are less than
 21 twenty-five dollars, the county treasurer may hold such funds until
 22 such time as they are equal to or exceed twenty-five dollars. In no
 23 case shall such funds be held by the county treasurer longer than six
 24 months.
- 25 <u>(c) If a school district treasurer has not filed an</u>

1 official bond pursuant to section 11-107 or evidence of equivalent

- 2 insurance coverage, the county treasurer may hold funds collected or
- 3 received for the school district until such time as the bond or
- 4 <u>evidence of equivalent insurance coverage has been filed.</u>
- 5 (5) Notwithstanding subsection (4) of this section, the
- 6 county treasurer of any county in which a city of the metropolitan
- 7 class or a Class V school district is located shall pay to the city
- 8 of the metropolitan class and to the Class V school district on a
- 9 weekly basis the amount of all current year funds as they become
- 10 available for the city or the school district.
