- 14 commission, shall be is guilty of a Class I misdemeanor.
- 15 (2)(a) Any person operating an advanced-deposit wagering
- 16 system or a secondary parimutuel organization that takes or receives
- 17 wagers from residents of this state on any thoroughbred horserace in
- 18 violation of sections 2-1201 to 2-1218 is guilty of a Class IV
- 19 felony.
- 20 <u>(b) For purposes of this subsection:</u>
- 21 <u>(i) Advanced-deposit wagering system means a system</u>
- 22 whereby wagers are debited and payouts credited to an advanced-
- 23 <u>deposit account held by an association or secondary parimutuel</u>
- 24 <u>organization; and</u>
- 25 (ii) Secondary parimutuel organization means an entity

1 other than a licensed association that offers and accepts parimutuel

- 2 wagers. Secondary parimutuel organization may include an off-track
- 3 wagering system or an account wagering system.
- 4 (c) Nothing in this subsection shall prohibit an
- 5 association or public benefit corporation licensed by the State
- 6 Racing Commission from establishing an advanced-deposit wagering
- 7 system at a racetrack so long as such association or public benefit
- 8 corporation complies with law and any rules and regulations adopted
- 9 and promulgated by the commission.
