13 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-3815, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 2-3815 The Department of Agriculture shall establish an
- 4 agriculture promotion and development program. The department shall
- 5 employ a program director and one specialist in research techniques
- 6 and market development. Both individuals shall report directly to the
- 7 Director of Agriculture.
- 8 The University of Nebraska Institute of Agriculture and
- 9 Natural Resources shall employ a poultry pathologist.
- 10 The program shall concentrate on the identification and
- 11 development of opportunities to enhance profitability in agriculture
- 12 and to stimulate agriculture-related economic development. Program
- 13 activities may include, but not be limited to, (1) promotion and
- 14 market development, (2) value-added processing of alternative and
- 15 traditional commodities, (3) agricultural diversification, including
- 16 poultry development and aquaculture, (4) agricultural cooperatives,
- 17 and (5) alternative crops.
- 18 In order to carry out the purposes of this section, the
- 19 program director may, if he or she deems necessary, convene an
- 20 advisory committee to assist the program director in developing and
- 21 implementing program activities. Representatives from the Nebraska
- 22 Food Processing Center, the Cooperative Extension Service of the
- 23 University of Nebraska, the commodity boards, the Department of
- 24 Economic Development, the United States Department of Agriculture
- 25 grant programs, and the private sector may serve on such committee at

1 the request of the program director. If an advisory committee is

- 2 convened, committee members shall not receive any reimbursement for
- 3 expenses.
- 4 The Department of Agriculture shall serve as the
- 5 facilitator, coordinator, and catalyst for developments through and
- 6 with the Nebraska Food Processing Center, the Cooperative Extension
- 7 Service of the University of Nebraska, the commodity boards, the
- 8 Department of Economic Development, other state agencies, the United
- 9 States Department of Agriculture grant programs, and the private
- 10 sector. It is the intent of the Legislature that the department
- 11 foster close working relationships between production agriculture and
- 12 existing programs for the purposes of agricultural development and
- 13 promotion. The department may enter into such contracts as may be
- 14 necessary to carry out the purposes of this section.
- For purposes of this section, unless the context
- 16 otherwise requires, private sector shall include, but not be limited
- 17 to, representatives of food industry associations, lenders, or
- 18 venture capital groups.
- 19 Sec. 2. Section 2-5003, Reissue Revised Statutes of
- 20 Nebraska, is amended to read:
- 21 2-5003 There is hereby created the Nebraska Aquaculture
- 22 Board. The board shall consist of (1) the aquaculturist employed by
- 23 the Cooperative Extension Service pursuant to section 85-1,104.01,
- 24 (2) one employee of the commission who is familiar with aquatic
- 25 disease, appointed by the secretary of the commission, $\frac{(3)}{(2)}$ one

1 employee of the department appointed by the director, $\frac{(4)}{(3)}$ three

- 2 aquaculturists, appointed by the Governor, and (5)—(4)—a
- 3 representative of an industry or product which is related to or used
- 4 in aquaculture, appointed by the Governor. The board shall elect from
- 5 its members a chairperson. The terms of the members of the board
- 6 shall be three years, except that the terms of the initial
- 7 aquaculturist members of the board appointed by the Governor shall be
- 8 staggered so that one member is appointed for a term of one year, one
- 9 for a term of two years, and one for a term of three years, as
- 10 determined by the Governor. Members appointed under subdivisions (3)
- 11 and (4) and (5) of this section shall be reimbursed for their actual
- 12 and necessary expenses as provided in sections 81-1174 to 81-1177.
- Sec. 3. Section 38-2620, Reissue Revised Statutes of
- 14 Nebraska, is amended to read:
- 15 38-2620 There is hereby established the Nebraska
- 16 Optometry Education Assistance Contract Program for the purpose of
- 17 providing opportunities for citizens of this state desiring to pursue
- 18 study in the field of optometry at accredited schools and colleges
- 19 outside the state. Eligibility for the program shall be limited as
- 20 provided in sections 38-2622 and 38-2623.
- 21 Sec. 4. Section 38-2622, Reissue Revised Statutes of
- 22 Nebraska, is amended to read:
- 23 38-2622 The total number of students receiving annual
- 24 Annual financial payments made under sections 38-2620 to 38-2623
- 25 shall not exceed sixty students during any school year. No more than

1 fifteen of these students shall be students enrolling in a college of

- 2 optometry for their first year of instruction. be limited to students
- 3 who participated in the program in the academic year 2010-11 and
- 4 shall continue for the remaining academic year or years that any such
- 5 student is enrolled in an accredited school or college of optometry
- 6 <u>subject to the limitation provided in section 38-2623.</u>
- 7 Sec. 5. Section 81-1273, Reissue Revised Statutes of
- 8 Nebraska, is amended to read:
- 9 81-1273 The Legislature finds and declares:
- 10 (1) That the availability of business development
- 11 services at various geographic locations throughout the state would
- 12 result in the retention, expansion, and diversification of existing
- 13 businesses and the creation of new businesses;
- 14 (2) That the Board of Regents of the University of
- 15 <u>Nebraska may authorize</u> the Nebraska Business Development Center, as a
- 16 department of the University of Nebraska at Omaha. The Nebraska
- 17 Business Development Center, if authorized under this section, may 7
- 18 shall—provide business development services through a network of
- 19 small business development centers at: (a) Chadron State College,
- 20 Peru State College, and Wayne State College, if authorized by the
- 21 Board of Trustees of the Nebraska State Colleges; and (b) the
- 22 University of Nebraska at Kearney, the University of Nebraska-
- 23 Lincoln, and the University of Nebraska at Omaha, and Wayne State
- 24 College; if authorized by the Board of Regents of the University of
- 25 <u>Nebraska;</u>

1 (3) That business development services may be augmented

- 2 through specialized research and technical assistance services; and
- 3 (4) That the Existing Business Assistance Division of the
- 4 Department of Economic Development shall coordinate, administer, and
- 5 support the delivery of such services.
- 6 Sec. 6. Section 81-1275, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 81-1275 The—If the Nebraska Business Development Center
- 9 is authorized by the Board of Regents of the University of Nebraska
- 10 <u>pursuant to section 81-1273, the Existing Business Assistance</u>
- 11 Division shall contract with the Nebraska Business Development Center
- 12 to administer, manage, and deliver regional small business services,
- 13 and the Nebraska Business Development Center shall:
- 14 (1) Provide such services as close as possible to small
- 15 businesses through a network of small business development centers
- 16 located in Omaha, Lincoln, Kearney, Wayne, North Platte, Scottsbluff
- 17 or Gering, Chadron, Peru, and such other communities as the Existing
- 18 Business Assistance Division shall determine based on the
- 19 applications of communities desiring to be the location of a small
- 20 business development center. Small business development centers in
- 21 such communities shall not be required if the location within a
- 22 community is on property under the control of the Board of Regents of
- 23 <u>the University of Nebraska or the Board of Trustees of the Nebraska</u>
- 24 State Colleges and the governing body with control of such property
- 25 has not authorized such small business development center pursuant to

1 section 81-1273. In determining the location of small business

- 2 development centers, the division shall consider several factors,
- 3 including, but not limited to: (a) Preexisting small business
- 4 development centers; (b) geographic accessibility; and (c) existing
- 5 resources such as building space and office equipment or the
- 6 willingness of a community to provide some or all of those resources.
- 7 The division shall prescribe the form of the application for location
- 8 of a small business development center and take all actions necessary
- 9 in the processing of such applications;
- 10 (2) Integrate activities funded through the Business
- 11 Development Partnership Act with those funded by the United States
- 12 Small Business Administration or any other program supporting the
- 13 Nebraska small business development centers;
- 14 (3) Furnish one-to-one individual counseling to small
- 15 businesses;
- 16 (4) Assist in technology transfer, research, and coupling
- 17 from existing sources to small businesses;
- 18 (5) Maintain current information concerning federal,
- 19 state, and local regulations that affect small businesses and counsel
- 20 small business on methods of compliance;
- 21 (6) Coordinate and conduct research into technical and
- 22 general small business problems for which there are no ready
- 23 solutions;
- 24 (7) Provide and maintain a comprehensive library that
- 25 contains current information and statistical data needed by small

- 1 businesses;
- 2 (8) Maintain a working relationship and open
- 3 communications with the financial and investment communities, legal
- 4 associations, local and regional private consultants, and local and
- 5 regional small business groups and associations in order to help
- 6 address the various needs of the small business community;
- 7 (9) Conduct indepth surveys for local small business
- 8 groups in order to develop general information regarding the local
- 9 economy and general small business strengths and weaknesses in the
- 10 locality; and
- 11 (10) Provide other services as determined in consultation
- 12 with the Existing Business Assistance Division.
- Sec. 7. Section 85-214, Reissue Revised Statutes of
- 14 Nebraska, is amended to read:
- 15 85-214 The Board of Regents shall have control and
- 16 supervision of the research and extension centers and agricultural
- 17 laboratory established by sections 85-2017 and 85-2067, and 85-209 and
- 18 shall appoint skillful superintendents and such other employees as to
- 19 it appears necessary to obtain the best results. The board shall fix
- 20 the salaries and compensation of employees and establish such rules
- 21 and regulations as it may from time to time deem best.
- 22 Sec. 8. Section 85-215, Reissue Revised Statutes of
- 23 Nebraska, is amended to read:
- 24 85-215 The proceeds arising from the sale of products of
- 25 the various research and extension centers and agricultural

1 laboratory provided for in sections 85-201, and 85-206, and 85-209

- 2 shall be applied to the liquidation of the running expenses of the
- 3 research and extension centers and agricultural laboratory from which
- 4 they are sold, and all money so accruing shall be credited as coming
- 5 from the state and be applied as a part or whole payment of any
- 6 amount which may be appropriated from the funds of the state for the
- 7 maintenance of such research and extension centers. and agricultural
- 8 laboratory.
- 9 Sec. 9. Section 85-1005, Reissue Revised Statutes of
- 10 Nebraska, is amended to read:
- 11 85-1005 (1) The Board of Regents of the University of
- 12 Nebraska may accept and administer, in accordance with proper
- 13 financial procedures at the University of Nebraska at Kearney, gifts,
- 14 grants, tuition, <u>fees</u>, and private funds to assist in the operation
- 15 of the center.
- 16 (2) The Board of Regents of the University of Nebraska
- 17 shall may request an appropriation of such money from the General
- 18 Fund as may be necessary to permit the center to operate efficiently
- 19 and to assist in the operation of the center to promote the purposes
- 20 of sections 85-1001 to 85-1008.
- 21 Sec. 10. Original sections 2-3815, 2-5003, 38-2620,
- 22 38-2622, 81-1273, 81-1275, 85-214, 85-215, and 85-1005, Reissue
- 23 Revised Statutes of Nebraska, are repealed.
- 24 Sec. 11. The following sections are outright repealed:
- 25 Sections 85-1,104.01, 85-209, 85-210, 85-211, and 85-212, Reissue
