A BILL

1	FOR AN ACT	relating to the Game and Parks Commission; to authorize
2		the commission to convey certain real estate for park
3		purposes; to prescribe conditions relating to the
4		conveyance, operation, and maintenance of the real
5		estate; and to declare an emergency.

6 Be it enacted by the people of the State of Nebraska,

1	Section 1. The Game and Parks Commission is authorized to
2	convey to the village of Brownville, Nebraska, for public park
3	purposes the following described real estate now known as Brownville
4	State Recreation Area, situated in the county of Nemaha, in the State
5	<u>of Nebraska, to wit:</u>
