### A BILL

- 1 FOR AN ACT relating to the Legislature; to amend section 50-401.01, 2 Reissue Revised Statutes of Nebraska; to change 3 provisions relating to membership on the Executive Board 4 of the Legislative Council; and to repeal the original 5 section. 6
- Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 50-401.01, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 50-401.01 (1) The Legislative Council shall have an
- 4 executive board, to be known as the Executive Board of the
- 5 Legislative Council, which shall consist of a chairperson, a vice-
- 6 chairperson, and six members of the Legislature, to be chosen by the
- 7 Legislature at the commencement of each regular session of the
- 8 Legislature when the speaker is chosen, and the Speaker of the
- 9 Legislature. The Legislature at large shall elect two of its members
- 10 from legislative districts Nos. 1, 2, 15, 21 to 30, 32, 34, and 46,
- 11 <u>1, 17, 32 to 38, 40 to 44, 47, and 48, two from legislative districts</u>
- 12 Nos. 3 to 14, 18, 20, 31, 39, and 45, 2, 15, 16, 19, 21 to 30, 45,
- 13 and 46, and two from legislative districts Nos. 16, 17, 19, 33, 35 to
- 14 38, 40 to 44, and 47 to 49. 3 to 14, 18, 20, 31, 39, and 49. The
- 15 Chairperson of the Committee on Appropriations shall serve as a
- 16 nonvoting ex officio member of the executive board whenever the board
- 17 is considering fiscal administration.
- 18 (2) The executive board shall:
- 19 (a) Supervise all services and service personnel of the
- 20 Legislature and may employ and fix compensation and other terms of
- 21 employment for such personnel as may be needed to carry out the
- 22 intent and activities of the Legislature or of the board, unless
- 23 otherwise directed by the Legislature, including the adoption of
- 24 policies by the executive board which permit (i) the purchasing of an
- 25 annuity for an employee who retires or (ii) the crediting of amounts

1 to an employee's deferred compensation account under section 84-1504.

- 2 The payments to or on behalf of an employee may be staggered to
- 3 comply with other law; and
- 4 (b) Appoint persons to fill the positions of Legislative
- 5 Fiscal Analyst, Director of Research, Revisor of Statutes, and
- 6 Legislative Auditor. The persons appointed to these positions shall
- 7 have training and experience as determined by the executive board and
- 8 shall serve at the pleasure of the executive board. The Legislative
- 9 Performance Audit Committee shall recommend the person to be
- 10 appointed Legislative Auditor. Their respective salaries shall be set
- 11 by the executive board.
- 12 (3) Notwithstanding any other provision of law, the
- 13 executive board may contract to obtain legal, auditing, accounting,
- 14 actuarial, or other professional services or advice for or on behalf
- of the executive board, the Legislative Council, the Legislature, or
- 16 any member of the Legislature. The providers of such services or
- 17 advice shall meet or exceed the minimum professional standards or
- 18 requirements established or specified by their respective
- 19 professional organizations or licensing entities or by federal law.
- 20 Such contracts, the deliberations of the executive board with respect
- 21 to such contracts, and the work product resulting from such contracts
- 22 shall not be subject to review or approval by any other entity of
- 23 state government.
