1	FOR AN ACT	relating to government; to amend sections 60-396 and
2		60-3,104, Reissue Revised Statutes of Nebraska, and
3		sections 60-301, 60-393, and 60-395, Revised Statutes
4		Supplement, 2011; to provide for Nebraska Armed Forces
5		Pride Plates; to create a fund; to provide for funding
6		for Nebraska veterans homes; to harmonize provisions; and
7		to repeal the original sections.
8	Be it enact	ed by the people of the State of Nebraska,

1 Section 1. Section 60-301, Revised Statutes Supplement,

- 2 2011, is amended to read:
- 3 60-301 Sections 60-301 to 60-3,222 <u>and sections 6 and 7</u>
- 4 of this act shall be known and may be cited as the Motor Vehicle
- 5 Registration Act.
- 6 Sec. 2. Section 60-393, Revised Statutes Supplement,
- 7 2011, is amended to read:
- 8 60-393 Any owner who has two or more motor vehicles or
- 9 trailers required to be registered under the Motor Vehicle
- 10 Registration Act may register all such motor vehicles or trailers on
- 11 a calendar-year basis or on an annual basis for the same registration
- 12 period beginning in a month chosen by the owner. When electing to
- 13 establish the same registration period for all such motor vehicles or
- 14 trailers, the owner shall pay the registration fee, the motor vehicle
- 15 tax imposed in section 60-3,185, the motor vehicle fee imposed in
- 16 section 60-3,190, and the alternative fuel fee imposed in section
- 17 60-3,191 on each motor vehicle for the number of months necessary to
- 18 extend its current registration period to the registration period
- 19 under which all such motor vehicles or trailers will be registered.
- 20 Credit shall be given for registration paid on each motor vehicle or
- 21 trailer when the motor vehicle or trailer has a later expiration date
- 22 than that chosen by the owner except as otherwise provided in
- 23 sections 60-3,121, 60-3,122.02, and 60-3,128 and section 7 of this
- 24 <u>act</u>. Thereafter all such motor vehicles or trailers shall be
- 25 registered on an annual basis starting in the month chosen by the

- 2 Sec. 3. Section 60-395, Revised Statutes Supplement,
- 3 2011, is amended to read:
- 4 60-395 (1) Except as otherwise provided in subsection (2)
- 5 of this section and sections 60-3,121, 60-3,122.02, and 60-3,128 and
- 6 section 7 of this act, the registration shall expire and the
- 7 registered owner or lessee may, by returning the registration
- 8 certificate, the license plates, and, when appropriate, the
- 9 validation decals and by either making application on a form
- 10 prescribed by the department to the county treasurer or designated
- 11 county official of the occurrence of an event described in
- 12 subdivisions (a) through (e) of this subsection or, in the case of a
- 13 change in situs, displaying to the county treasurer or designated
- 14 county official the registration certificate of such other state as
- 15 evidence of a change in situs, receive a refund of that part of the
- 16 unused fees and taxes on motor vehicles or trailers based on the
- 17 number of unexpired months remaining in the registration period from
- 18 the date of any of the following events:
- 19 (a) Upon transfer of ownership of any motor vehicle or

- 25 (d) Whenever a type or class of motor vehicle or trailer

1 previously registered is subsequently declared by legislative act or

- 2 court decision to be illegal or ineligible to be operated or towed on
- 3 the public roads and no longer subject to registration fees, the
- 4 motor vehicle tax imposed in section 60-3,185, the motor vehicle fee
- 5 imposed in section 60-3,190, and the alternative fuel fee imposed in
- 6 section 60-3,191;
- 7 (e) Upon a trade-in or surrender of a motor vehicle under
- 8 a lease; or
- 9 (f) In case of a change in the situs of a motor vehicle
- 10 or trailer to a location outside of this state.
- 11 (2) If the date of the event falls within the same
- 12 calendar month in which the motor vehicle or trailer is acquired, no
- 13 refund shall be allowed for such month.
- 14 (3) If the transferor or lessee acquires another motor
- 15 vehicle at the time of the transfer, trade-in, or surrender, the
- 16 transferor or lessee shall have the credit provided for in this
- 17 section applied toward payment of the motor vehicle fees and taxes
- 18 then owing. Otherwise, the transferor or lessee shall file a claim
- 19 for refund with the county treasurer or designated county official
- 20 upon an application form prescribed by the department.
- 21 (4) The registered owner or lessee shall make a claim for
- 22 refund or credit of the fees and taxes for the unexpired months in
- 23 the registration period within sixty days after the date of the event
- 24 or shall be deemed to have forfeited his or her right to such refund
- 25 or credit.

1 (5) For purposes of this section, the date of the event

- 2 shall be: (a) In the case of a transfer or loss, the date of the
- 3 transfer or loss; (b) in the case of a change in the situs, the date
- 4 of registration in another state; (c) in the case of a trade-in or
- 5 surrender under a lease, the date of trade-in or surrender; (d) in
- 6 the case of a legislative act, the effective date of the act; and (e)
- 7 in the case of a court decision, the date the decision is rendered.
- 8 (6) Application for registration or for reassignment of
- 9 license plates and, when appropriate, validation decals to another
- 10 motor vehicle or trailer shall be made within thirty days of the date
- 11 of purchase.
- 12 (7) If a motor vehicle or trailer was reported stolen
- 13 under section 60-178, a refund under this section shall not be
- 14 reduced for a lost plate charge and a credit under this section may
- 15 be reduced for a lost plate charge but the applicant shall not be
- 16 required to pay the plate fee for new plates.
- 17 (8) The county treasurer or designated county official
- 18 shall refund the motor vehicle fee and registration fee from the fees
- 19 which have not been transferred to the State Treasurer. The county
- 20 treasurer shall make payment to the claimant from the undistributed
- 21 motor vehicle taxes of the taxing unit where the tax money was
- 22 originally distributed. No refund of less than two dollars shall be
- 23 paid.
- Sec. 4. Section 60-396, Reissue Revised Statutes of
- 25 Nebraska, is amended to read:

1 60-396 Whenever the registered owner files an application 2 with the county treasurer or designated county official showing that a motor vehicle or trailer is disabled and has been removed from 3 service, the registered owner may, by returning the registration 4 5 certificate, the license plates, and, when appropriate, validation decals or, in the case of the unavailability of such 6 7 registration certificate or certificates, license plates, 8 validation decals, then by making an affidavit to the county treasurer or designated county official of such disablement and 9 removal from service, receive a credit for a portion of 10 registration fee from the fee deposited with the State Treasurer at 11 12 the time of registration based upon the number of unexpired months remaining in the registration year except as otherwise provided in 13 14 sections 60-3,121, 60-3,122.02, and 60-3,128 and section 7 of this 15 act. The owner shall also receive a credit for the unused portion of the motor vehicle tax and fee based upon the number of unexpired 16 months remaining in the registration year. When the owner registers a 17 replacement motor vehicle or trailer at the time of filing such 18 affidavit, the credit may be immediately applied against 19 the 20 registration fee and the motor vehicle tax and fee for the replacement motor vehicle or trailer. When no such replacement motor 21 vehicle or trailer is so registered, the county treasurer 22 23 designated county official shall forward the application affidavit, if any, to the State Treasurer who shall determine the 24 amount, if any, of the allowable credit for the registration fee and 25

1 issue a credit certificate to the owner. For the motor vehicle tax

- 2 and fee, the county treasurer or designated county official shall
- 3 determine the amount, if any, of the allowable credit and issue a
- 4 credit certificate to the owner. When such motor vehicle or trailer
- 5 is removed from service within the same month in which it was
- 6 registered, no credits shall be allowed for such month. The credits
- 7 may be applied against taxes and fees for new or replacement motor
- 8 vehicles or trailers incurred within one year after cancellation of
- 9 registration of the motor vehicle or trailer for which the credits
- 10 were allowed. When any such motor vehicle or trailer is reregistered
- 11 within the same registration year in which its registration has been
- 12 canceled, the taxes and fees shall be that portion of the
- 13 registration fee and the motor vehicle tax and fee for the remainder
- 14 of the registration year.

- 7 Sec. 6. (1) The department shall design license plates to
- 8 <u>be known as Nebraska Armed Forces Pride Plates. The department shall</u>
- 9 <u>design the plates in consultation with the Department of Veterans'</u>
- 10 Affairs, the Military Department, and related military organizations.
- 11 The Department of Veterans' Affairs shall recommend the design of the
- 12 plate to the Department of Motor Vehicles. The department shall
- 13 ensure that the design provides for:
- 14 <u>(a) The prominent display on the left side or center of</u>
- 15 the license plate of the seal or symbol of one of the following armed
- 16 forces: Army, Navy, Marine Corps, Coast Guard, Air Force, or Nebraska
- 17 National Guard;
- 18 (b) The notable display of the words Active Duty,
- 19 Veteran, Reservist, or Retired preceded by the applicable armed force
- 20 under the license plate number;
- 21 (c) Common background colors determined to best provide
- 22 <u>suitable reflection and contrast and blend well with the design and</u>
- 23 colors of each armed service seal or symbol;
- 24 (d) A reflection of support for Nebraskans who have or
- 25 <u>are serving in the armed forces; and</u>

1 (e) Enhanced desirability of Nebraska Armed Forces Pride

- 2 Plates to former and present armed forces personnel. The design shall
- 3 be selected on the basis of limiting the manufacturing cost of each
- 4 plate to an amount less than or equal to the amount charged for
- 5 license plates pursuant to section 60-3,102. The department shall
- 6 make applications available for this type of plate when it is
- 7 designed. The department may adopt and promulgate rules and
- 8 regulations to carry out this section and section 60-3,122.02.
- 9 (2) One type of Nebraska Armed Forces Pride Plate shall
- 10 <u>be consecutively numbered plates. The department shall:</u>
- 11 (a) Number the plates consecutively for each armed force
- 12 beginning with the number zero zero one, using numerals the size
- 13 of which maximizes legibility and limiting the numerals to five
- 14 <u>characters or less; and</u>
- (b) Not use a county designation or any characters other
- 16 than numbers on the plates.
- 17 (3) One type of Nebraska Armed Forces Pride Plate shall
- 18 be personalized message plates. Such plates shall be issued subject
- 19 to the same conditions specified for personalized message license
- 20 plates in section 60-3,118, except that a maximum of five characters
- 21 <u>may be used.</u>
- 22 Sec. 7. (1) Beginning January 2, 2013, an eligible person
- 23 may apply to the department for Nebraska Armed Forces Pride Plates in
- 24 lieu of regular license plates on an application prescribed and
- 25 provided by the department for any motor vehicle, trailer,

semitrailer, or cabin trailer, except for a motor vehicle or trailer 1 registered under section 60-3,198. An applicant receiving a Nebraska 2 3 Armed Forces Pride Plate for a farm truck with a gross weight of over 4 sixteen tons shall affix the appropriate tonnage decal to the plate. 5 The department shall make forms available for such applications through the county treasurers. The license plates shall be issued 6 7 upon payment of the license fee described in subsection (2) of this 8 section and furnishing proof satisfactory to the department that the 9 applicant is (a) an honorably serving active duty armed forces 10 personnel serving in any of the armed forces listed in subdivision (1)(a) of section 6 of this act, (b) an honorably serving armed 11 12 forces reservist of any of such armed forces, (c) an honorably 13 discharged veteran of any of such armed forces, (d) an honorably 14 discharged retiree of any of such armed forces, or (e) the surviving spouse of any of such eligible armed forces personnel. An honorably 15 16 retired armed forces personnel may select either the word Veteran or 17 Retired preceded by the applicable armed force. A veteran or retiree or the surviving spouse of a veteran or retiree who served in more 18 than one of the armed forces may, upon proof of such service 19 20 satisfactory to the department, select the armed force to be 21 represented on the Nebraska Armed Forces Pride Plates. Any person 22 using Nebraska Armed Forces Pride Plates shall surrender the plates to the county treasurer if such person is no longer eligible for the 23 plates or is convicted of a felony which would result in the loss of 24 military benefits. An active duty nonresident armed forces personnel 25

1 shall surrender the Nebraska Armed Forces Pride Plates to the county

- 2 treasurer when such person is in receipt of permanent change of
- 3 station orders which transfer such person out of Nebraska. Regular
- 4 plates shall be issued to any such person upon surrender of the
- 5 Nebraska Armed Forces Pride Plates for a three-dollar transfer fee
- 6 and forfeiture of any of the remaining annual fee. The three-dollar
- 7 transfer fee shall be remitted to the State Treasurer for credit to
- 8 the Department of Motor Vehicles Cash Fund.
- 9 (2)(a) Each application for initial issuance or renewal
- 10 of consecutively numbered plates shall be accompanied by a fee of
- 11 five dollars. County treasurers collecting fees for renewals pursuant
- 12 to this subdivision shall remit them to the State Treasurer. The
- 13 State Treasurer shall credit five dollars of the fee for initial
- 14 issuance and renewal of such plates to the Nebraska Armed Forces
- 15 <u>Pride Plates Fund.</u>
- 16 (b) Each application for initial issuance or renewal of
- 17 personalized message Nebraska Armed Forces Pride Plates shall be
- 18 accompanied by a fee of forty dollars. County treasurers collecting
- 19 fees for renewals pursuant to this subdivision shall remit them to
- 20 <u>the State Treasurer. The State Treasurer shall credit twenty-five</u>
- 21 percent of the fee for initial issuance and renewal of such plates to
- 22 the Department of Motor Vehicles Cash Fund and seventy-five percent
- of the fee to the Nebraska Armed Forces Pride Plates Fund.
- 24 (3) When the department receives an application for
- 25 Nebraska Armed Forces Pride Plates, the department shall deliver the

1 plates to the county treasurer of the county in which the motor

- 2 vehicle or cabin trailer is registered. The county treasurer shall
- 3 issue Nebraska Armed Forces Pride Plates in lieu of regular license
- 4 plates when the applicant complies with the other provisions of the
- 5 Motor Vehicle Registration Act for registration of the motor vehicle
- 6 or cabin trailer. If Nebraska Armed Forces Pride Plates are lost,
- 7 stolen, or mutilated, the licensee shall be issued replacement
- 8 license plates upon request and without charge.
- 9 (4) The owner of a motor vehicle or cabin trailer bearing
- 10 Nebraska Armed Forces Pride Plates may apply to the county treasurer
- 11 to have such plates transferred to a motor vehicle other than the
- 12 vehicle for which such plates were originally purchased if such
- 13 vehicle is owned by the owner of the plates. The owner may have the
- 14 unused portion of the fee for the plates credited to the other
- 15 vehicle which will bear the plates at the rate of eight and one-third
- 16 percent per month for each full month left in the registration
- 17 period. Application for such transfer shall be accompanied by a fee
- 18 of three dollars. Fees collected pursuant to this subsection shall be
- 19 remitted to the State Treasurer for credit to the Department of Motor
- 20 Vehicles Cash Fund.
- 21 (5) If the cost of manufacturing Nebraska Armed Forces
- 22 Pride Plates at any time exceeds the amount charged for license
- 23 plates pursuant to section 60-3,102, any money to be credited to the
- 24 Nebraska Armed Forces Pride Plates Fund shall instead be credited
- 25 first to the Highway Trust Fund in an amount equal to the difference

1 <u>between the manufacturing costs of Nebraska Armed Forces Pride Plates</u>

- 2 and the amount charged pursuant to section 60-3,102 with respect to
- 3 such plates and the remainder shall be credited to the Nebraska Armed
- 4 Forces Pride Plates Fund.

5 Sec. 8. The Nebraska Armed Forces Pride Plates Fund is created. The fund shall consist of fees credited pursuant to section 6 7 7 of this act. Twenty-five percent of the fund shall be used to 8 support operations and maintenance of the Nebraska veterans homes in 9 addition to the funding normally provided by the Legislature for the 10 Nebraska veterans homes, and seventy-five percent of the fund shall be used to support quality of life improvements, including, but not 11 12 limited to, maintaining up-to-date electronic devices and equipment 13 such as televisions, computers, computer accessories, and Internet 14 fees, making them available for use by all veterans residing in the 15 Nebraska veterans homes. Except as provided in this section, the 16 Legislature shall not consider money in the fund when providing 17 funding for the Nebraska veterans homes and the Department of Veterans' Affairs. The Director of Veterans' Affairs, the chief 18 19 executive officer of the Department of Health and Human Services, and 20 the director of each of the Nebraska veterans homes, or their 21 designees, shall meet at least once annually to determine how the 22 accumulated funds in the fund shall be spent in support of the Nebraska veterans homes. Any money in the fund available for 23 24 investment shall be invested by the state investment officer pursuant

to the Nebraska Capital Expansion Act and the Nebraska State Funds
