  Revised Statutes Supplement, 2011; to create a fund; to
  provide for fund transfers; and to repeal the original
  section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. The State Colleges Sport Facilities Cash Fund 2 is created. The fund shall be administered by the Board of Trustees of the Nebraska State Colleges. The fund shall include transfers from 3 4 the Civic and Community Center Financing Fund, revenue received from 5 gifts, grants, bequests, donations, other similar donation arrangements, or other contributions from public or private sources, 6 7 and such other revenue as may accrue to the fund. Expenditures from 8 the fund are authorized to support renovation and construction of or 9 improvements to facilities for intercollegiate athletics and student 10 fitness, recreation, and sport activities at the Nebraska State Colleges. Any money in the fund available for investment shall be 11 12 invested by the state investment officer pursuant to the Nebraska 13 Capital Expansion Act and the Nebraska State Funds Investment Act. Sec. 2. Section 13-2704, Revised Statutes Supplement, 14 2011, is amended to read: 15 16 13-2704 (1) The Civic and Community Center Financing Fund is created. The fund shall be administered by the department. 17 Transfers may be made from the fund to the General Fund at the 18 19 direction of the Legislature. Any money in the Civic and Community 20 Center Financing Fund available for investment shall be invested by the state investment officer pursuant to the Nebraska Capital 21 22 Expansion Act and the Nebraska State Funds Investment Act. The fund may be used for assistance for the construction of new civic centers, 23 24 the renovation or expansion of existing civic or community centers, or the conversion, rehabilitation, or reuse of historic buildings for 25

1 purposes consistent with this section. The fund may not be used for

- 2 programming, marketing, advertising, and related activities.
- 3 Transfers may be made from the fund to the Department of Revenue
- 4 Enforcement Fund and to the State Colleges Sport Facilities Cash Fund
- 5 at the direction of the Legislature.
- 6 (2) It is the intent of the Legislature that on July 1,
- 7 2011, or as soon thereafter as is administratively possible the State
- 8 Treasurer shall transfer forty-two thousand nine hundred dollars from
- 9 the Civic and Community Center Financing Fund to the Department of
- 10 Revenue Enforcement Fund.
- 11 (3) The State Treasurer shall transfer two hundred fifty
- 12 thousand dollars from the Civic and Community Center Financing Fund
- 13 to the State Colleges Sport Facilities Cash Fund on October 1 of
- 14 <u>2012</u>, 2013, and 2014. Commencing October 1, 2015, and every year
- 15 thereafter, the State Treasurer shall transfer four hundred thousand
- 16 dollars from the Civic and Community Center Financing Fund to the
- 17 <u>State Colleges Sport Facilities Cash Fund.</u>
