SPEAKER FLOOD: Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the fourth day of the One Hundred Second Legislature, First Session. Our chaplain for today is Reverend Steve Flader, South Gate United Methodist Church in Lincoln, Nebraska, Senator Fulton's district. Please rise. []

REVEREND FLADER: First of all, let us join with the rest of the country in a moment of silence for the victims of the shootings in Arizona as we remember Federal Judge Roll and Congresswoman Giffords in her continued recovery and the other losses of that time. Let us spend a moment in silence. (Prayer offered.) []

SPEAKER FLOOD: Thank you. I call to order the fourth day of the One Hundred Second Legislature, First Session. Senators, please record your presence. Mr. Clerk, please record. []

SPEAKER FLOOD: Thank you, Mr. Clerk. Are there any corrections for the Journal? []
