1           1. Strike the original sections and all amendments  
2 thereto and insert the following new sections:

3           Section 1. Section 32-101, Revised Statutes Supplement,  
4 2013, is amended to read:

5           32-101 Sections 32-101 to 32-1551 and section 3 of this  
6 act shall be known and may be cited as the Election Act.

7           Sec. 2. Section 32-204, Reissue Revised Statutes of  
8 Nebraska, is amended to read:

9           32-204 The Election Administration Fund is hereby  
10 created. The fund shall consist of federal funds, state funds,  
11 gifts, and grants appropriated for the administration of elections.  
12 The Secretary of State shall use the fund for voting systems,  
13 provisional voting, computerized statewide voter registration  
14 lists, voter registration, by mail, training or informational  
15 materials related to elections, and any other costs related to  
16 elections. Any money in the fund available for investment shall be  
17 invested by the state investment officer pursuant to the Nebraska  
18 Capital Expansion Act and the Nebraska State Funds Investment  
19 Act. ~~The State Treasurer shall transfer any money in the Voter~~  
20 ~~Registration Cash Fund on February 21, 2003, to the Election~~  
21 ~~Administration Fund.~~

22           Sec. 3. (1) The Secretary of State in conjunction with  
23 the Department of Motor Vehicles shall, on or before July 1, 2015,

1 develop and implement a registration application process which may  
2 be used statewide to register to vote and update voter registration  
3 records electronically using the Secretary of State's web site. An  
4 applicant who has a valid Nebraska motor vehicle operator's license  
5 or state identification card may use the application process to  
6 register to vote or to update his or her voter registration  
7 record with changes in his or her personal information or other  
8 information related to his or her eligibility to vote. For each  
9 electronic application, the Secretary of State shall obtain a  
10 copy of the electronic representation of the applicant's signature  
11 from the Department of Motor Vehicles' records of his or her  
12 motor vehicle operator's license or state identification card for  
13 purposes of voter registration.

14 (2) The application shall contain substantially all  
15 the information provided in section 32-312 and the following  
16 informational statements:

17 (a) An applicant who submits this application  
18 electronically is affirming that the information in the application  
19 is true. Any applicant who submits this application electronically  
20 knowing that any of the information in the application is false  
21 shall be guilty of a Class IV felony under section 32-1502 of the  
22 statutes of Nebraska. The penalty for a Class IV felony is up to  
23 five years imprisonment, a fine of up to ten thousand dollars, or  
24 both;

25 (b) An applicant who submits this application  
26 electronically is agreeing to the use of his or her signature  
27 from the Department of Motor Vehicles' records of his or her

1 motor vehicle operator's license or state identification card for  
2 purposes of voter registration;

3 (c) To vote at the polling place on election day, the  
4 completed application must be submitted on or before the third  
5 Friday before the election; and

6 (d) The election commissioner or county clerk will, upon  
7 receipt of the application for registration, send an acknowledgment  
8 of registration to the applicant indicating whether the application  
9 is proper or not.

10 Sec. 4. Section 32-308, Reissue Revised Statutes of  
11 Nebraska, is amended to read:

12 32-308 (1) The Secretary of State and the Director of  
13 Motor Vehicles shall enter into an agreement to match information  
14 in the computerized statewide voter registration list with  
15 information in the data base of the Department of Motor Vehicles  
16 to the extent required to enable each such official to verify the  
17 accuracy of the information provided on applications for voter  
18 registration. The Director of Motor Vehicles shall enter into an  
19 agreement with the Commissioner of Social Security under section  
20 205(r) (8) of the federal Social Security Act, 42 U.S.C. 405(r) (8),  
21 as such section existed on April 17, 2003, for purposes of the  
22 Election Act.

23 (2) The Department of Motor Vehicles, with the assistance  
24 of the Secretary of State, shall prescribe a voter registration  
25 application which may be used to register to vote or change his or  
26 her address for voting purposes at the same time an elector applies  
27 for an original or renewal motor vehicle operator's license, an

1 original or renewal state identification card, or a replacement or  
2 duplicate thereof. The voter registration application shall contain  
3 the information required pursuant to section 32-312 and shall be  
4 designed so that it does not require the duplication of information  
5 in the application for the motor vehicle operator's license or  
6 state identification card, except that it may require a second  
7 signature of the applicant. The department and the Secretary of  
8 State shall make the voter registration application available to  
9 ~~the county treasurer, the license examiners of the department,~~  
10 ~~and any other person who issues operators' licenses or state~~  
11 ~~identification cards.~~ any person applying for an operator's license  
12 or state identification card. The application shall be completed  
13 at the office of the ~~county treasurer or~~ department by the close  
14 of business on the third Friday preceding any election to be  
15 registered to vote at such election. A registration application  
16 received after the deadline shall not be processed by the election  
17 commissioner or county clerk until after the election.

18 (3) The Department of Motor Vehicles, in conjunction with  
19 the Secretary of State, shall develop a process to electronically  
20 transmit voter registration application information received under  
21 subsection (2) of this section to the election commissioner or  
22 county clerk of the county in which the applicant resides within  
23 the time limits prescribed in subsection (4) of this section. The  
24 Director of Motor Vehicles shall designate an implementation date  
25 for the process which shall be on or before January 1, 2016.

26 (4) The voter registration application information shall  
27 be transmitted to the election commissioner or county clerk of

1 the county in which the applicant resides not later than ten days  
2 after receipt, except that if the voter registration application  
3 information is received within five days prior to the third Friday  
4 preceding any election, it shall be transmitted not later than five  
5 days after its original submission. Any information on whether an  
6 applicant registers or declines to register and the location of the  
7 office at which he or she registers shall be confidential and shall  
8 only be used for voter registration purposes.

9       (5) For each voter registration application for which  
10 information is transmitted electronically pursuant to this section,  
11 the Secretary of State shall obtain a copy of the electronic  
12 representation of the applicant's signature from the Department of  
13 Motor Vehicles' records of his or her motor vehicle operator's  
14 license or state identification card for purposes of voter  
15 registration. Each voter registration application electronically  
16 transmitted under this section shall include information provided  
17 by the applicant that includes whether the applicant is a citizen  
18 of the United States, whether the applicant is of sufficient  
19 age to register to vote, the applicant's residence address, the  
20 applicant's postal address if different from the residence address,  
21 the date of birth of the applicant, the party affiliation of the  
22 applicant or an indication that the applicant is not affiliated  
23 with any political party, the applicant's motor vehicle operator's  
24 license number, the applicant's previous registration location  
25 by city, county, or state, if applicable, and the applicant's  
26 signature.

27       ~~(3)~~ (6) State agency personnel and county treasurers

1 involved in the voter registration process pursuant to this section  
2 and section 32-309 shall not be considered deputy registrars or  
3 agents or employees of the election commissioner or county clerk.

5 Nebraska, is amended to read:

6 32-309 Upon receipt of a completed voter registration  
7 application under subsection (2) of section 32-308, a county  
8 ~~treasurer, a license examiner of the Department of Motor Vehicles,~~  
9 ~~and any other person~~ who issues motor vehicle operators' licenses  
10 or state identification cards shall, until the implementation date  
11 designated by the Director of Motor Vehicles pursuant to subsection  
12 (3) of section 32-308, deliver the completed voter registration  
13 application to the election commissioner or county clerk of the  
14 county in which the ~~county treasurer, license examiner, or other~~  
15 person is located not later than ten days after receipt by  
16 the ~~county treasurer, license examiner, or other person,~~ except  
17 that if the voter registration application is received within

7 of an application, review, or change of address as provided in such  
8 section, or (4) the ~~office of the county treasurer or~~ Department  
9 of Motor Vehicles while applying for a motor vehicle operator's  
10 license or state identification card as provided in section 32-308.

11           Sec. 7. Section 32-312, Revised Statutes Cumulative  
12 Supplement, 2012, is amended to read:

13           32-312 The registration application prescribed by the  
14 Secretary of State pursuant to section 32-311.01 or section 3 of  
15 this act shall provide the instructional statements and request the  
16 information from the applicant as provided in this section.

17           CITIZENSHIP—"Are you a citizen of the United States of  
18 America?" with boxes to check to indicate whether the applicant is  
19 or is not a citizen of the United States.

20           AGE—"Are you at least eighteen years of age or will you  
21 be eighteen years of age on or before the first Tuesday following  
22 the first Monday of November of this year?" with boxes to check to  
23 indicate whether or not the applicant will be eighteen years of age  
24 or older on election day.

25           WARNING—"If you checked 'no' in response to either of  
26 these questions, do not complete this application.".

27           NAME—the name of the applicant giving the first and last

1 name in full, the middle name in full or the middle initial, and  
2 the maiden name of the applicant, if applicable.

3           RESIDENCE—the name and number of the street, avenue, or  
4 other location of the dwelling where the applicant resides if there  
5 is a number. If the registrant resides in a hotel, apartment,  
6 tenement house, or institution, such additional information shall  
7 be included as will give the exact location of such registrant's  
8 place of residence. If the registrant lives in an incorporated or  
9 unincorporated area not identified by the use of roads, road names,  
10 or house numbers, the registrant shall state the section, township,  
11 and range of his or her residence and the corporate name of the  
12 school district as described in section 79-405 in which he or she  
13 is located.

14           POSTAL ADDRESS—the address at which the applicant  
15 receives mail if different from the residence address.

16           ADDRESS OF LAST REGISTRATION—the name and number of the  
17 street, avenue, or other location of the dwelling from which the  
18 applicant last registered.

19           TELEPHONE NUMBERS—the telephone number of the applicant  
20 at work and at home. At the request of the applicant, a designation  
21 shall be made that the telephone number is an unlisted number,  
22 and such designation shall preclude the listing of the applicant's  
23 telephone number on any list of voter registrations.

24           EMAIL ADDRESS—an email address of the applicant. At the  
25 request of the applicant, a designation shall be made that the  
26 email address is private, and such designation shall preclude the  
27 listing of the applicant's email address on any list of voter

1 registrations.

2 DRIVER'S LICENSE NUMBER OR LAST FOUR DIGITS OF SOCIAL  
3 SECURITY NUMBER—if the applicant has a Nebraska driver's license,  
4 the license number, and if the applicant does not have a Nebraska  
5 driver's license, the last four digits of the applicant's social  
6 security number.

7 DATE OF APPLICATION FOR REGISTRATION—the month, day,  
8 and year when the applicant presented himself or herself for  
9 registration, ~~or~~ when the applicant completed and signed the  
10 registration application if the application was submitted by mail  
11 or delivered to the election official by the applicant's personal  
12 messenger or personal agent, or when the completed application was  
13 submitted if the registration application was completed pursuant to  
14 section 3 of this act.

15 PLACE OF BIRTH—show the state, country, kingdom, empire,  
16 or dominion where the applicant was born.

17 DATE OF BIRTH—show the date of the applicant's birth.  
18 The applicant shall be at least eighteen years of age or attain  
19 eighteen years of age on or before the first Tuesday after the  
20 first Monday in November to have the right to register and vote in  
21 any election in the present calendar year.

22 REGISTRATION TAKEN BY—show the signature of the  
23 authorized official or staff member accepting the application  
24 pursuant to section 32-309 or 32-310 or at least one of the deputy  
25 registrars taking the application pursuant to section 32-306, if  
26 applicable.

27 PARTY AFFILIATION—show the party affiliation of the

1 applicant as Democrat, Republican, or Other ..... or show  
2 no party affiliation as Nonpartisan. (Note: If you wish to vote in  
3 both partisan and nonpartisan primary elections for state and local  
4 offices, you must indicate a political party affiliation on the  
5 registration application. If you register without a political party  
6 affiliation (nonpartisan), you will receive only the nonpartisan  
7 ballots for state and local offices at primary elections. If you  
8 register without a political party affiliation, you may vote in  
9 partisan primary elections for congressional offices.)

10 OTHER-information the Secretary of State determines will  
11 assist in the proper and accurate registration of the voter.

12 Immediately following the spaces for inserting  
13 information as provided in this section, the following statement  
14 shall be printed:

15 To the best of my knowledge and belief, I declare under  
16 penalty of election falsification that:

17 (1) I live in the State of Nebraska at the address  
18 provided in this application;

19 (2) I have not been convicted of a felony or, if  
20 convicted, it has been at least two years since I completed my  
21 sentence for the felony, including any parole term;

22 (3) I have not been officially found to be non compos  
23 mentis (mentally incompetent); and

24 (4) I am a citizen of the United States.

25 Any registrant who signs this application knowing that  
26 any of the information in the application is false shall be guilty  
27 of a Class IV felony under section 32-1502 of the statutes of

1 Nebraska. The penalty for a Class IV felony is up to five years  
2 imprisonment, a fine of up to ten thousand dollars, or both.

3 APPLICANT'S SIGNATURE--require the applicant to affix his  
4 or her signature to the application.

5 Sec. 8. Section 32-312.05, Reissue Revised Statutes of  
6 Nebraska, is amended to read:

7 32-312.05 The date that a person's voter registration  
8 record or an update of his or her voter registration record becomes  
9 effective is the date the person presented himself or herself  
10 in person to register, the date the registration application  
11 was delivered to the election commissioner or county clerk,  
12 or the date the registration application was received by the  
13 election commissioner or county clerk if the person submitted the  
14 registration application by mail or pursuant to section 3 of this  
15 act or section 32-308.

16 Sec. 9. Section 32-315, Reissue Revised Statutes of  
17 Nebraska, is amended to read:

18 32-315 Upon receiving a completed voter registration  
19 application pursuant to section 32-308, 32-309, or 32-310  
20 indicating that a voter who is registered in the county has changed  
21 his or her name or moved to another residence within the same  
22 county, the election commissioner or county clerk shall change  
23 the voter registration record of the registered voter to the new  
24 name or new address and shall send an acknowledgment card to the  
25 registered voter indicating that the change of registration has  
26 been completed and the address of the voter's new polling place.

27 Sec. 10. Section 32-321, Reissue Revised Statutes of

1 Nebraska, is amended to read:

2           32-321 (1) Any elector may request a voter registration  
3 application from the office of the Secretary of State or the  
4 election commissioner or county clerk. The Secretary of State and  
5 the election commissioner or county clerk shall make registration  
6 applications prescribed by the Secretary of State available and may  
7 place the applications in public places. The Secretary of State  
8 and the election commissioner or county clerk may require that all  
9 unused applications be returned to his or her office and may place  
10 reasonable limits on the amount of applications requested.

11           (2) If an elector returns the completed application to  
12 the office of the Secretary of State or submits an application  
13 to the Secretary of State pursuant to section 3 of this act, the  
14 office shall deliver the application to the election commissioner  
15 or county clerk of the county in which the elector resides not  
16 later than ten days after receipt by the office, except that if  
17 the application is returned to the office or submitted pursuant to  
18 section 3 of this act within five days prior to the third Friday  
19 preceding any election, it shall be delivered not later than five  
20 days after the date it is returned. The deadline for returning a  
21 completed application to the office of the Secretary of State or  
22 submitting an application pursuant to section 3 of this act is  
23 the close of business on the third Friday preceding an election to  
24 be registered to vote at such election. A registration application  
25 received after the deadline shall not be processed by the election  
26 commissioner or county clerk until after the election. The office  
27 of the Secretary of State shall be a designated voter registration

1 agency for purposes of section 7 of the National Voter Registration  
2 Act of 1993, 42 U.S.C. 1973gg-5, as such section existed on March  
3 11, 2008.

4 (3) If an elector mails the registration application to  
5 the election commissioner or county clerk:

6 (a) (i) The application shall be postmarked on or before  
7 the third Friday before the next election; or

8 (ii) The application shall be received not later than  
9 the second Tuesday before the next election if the postmark is  
10 unreadable; and

11 (b) The application shall be processed by the election  
12 office as a proper registration for the voter to be entitled to  
13 vote on the day of the next election.

14 (4) If the registration application arrives after the  
15 registration deadline, the application shall not be processed  
16 until after the election. Written notice shall be given to  
17 any applicant whose registration application failed to meet the  
18 registration deadline or was found to be incorrect or incomplete  
19 and shall state the specific reason for rejection. If the  
20 application is incomplete, the election commissioner or county  
21 clerk shall notify the applicant of the failure to provide the  
22 required information, including failure to provide identification  
23 if required, and provide the applicant with the opportunity to  
24 submit an identification document as described in section 32-318.01  
25 prior to the deadline for voter registration or to complete and  
26 submit a corrected registration application in a timely manner to  
27 allow for the proper registration of the applicant prior to the

1 next election. All postage costs related to returning registration  
2 applications to the election commissioner or county clerk shall be

5 Nebraska, is amended to read:

6 32-323 Registration pursuant to section 3 of this act  
7 or section 32-308 or by mail shall not constitute a valid  
8 registration for purposes of signing any type of petition requiring  
9 the validation of the signatures of registered voters until a  
10 complete and correct registration application has been received  
11 by the election commissioner or county clerk. A signature on a  
12 petition shall be considered a valid signature as of the date that  
13 the election commissioner or county clerk receives the registration  
14 application of the registrant.

15 Sec. 12. Section 32-325, Reissue Revised Statutes of  
16 Nebraska, is amended to read:

17 32-325 (1) A registration application completed and  
18 signed by a registered voter seeking to update his or her voter  
19 registration record shall be completed in person at or delivered or  
20 mailed to the office of the election commissioner or county clerk  
21 or submitted pursuant to section 3 of this act to the Secretary  
22 of State. To avoid additional requirements at the polling place  
23 pursuant to section 32-914.01, 32-914.02, or 32-915, an application  
24 to update a voter registration record must be:

25 (a) Completed or delivered by the applicant in person  
26 at the office of the election commissioner or county clerk on or  
27 before the deadline prescribed in section 32-302; or

15 32-902 (1) The election commissioner or county clerk  
16 shall cause instructions for the guidance of registered voters in  
17 preparing their ballots to be printed in large, clear type on  
18 cards in English. He or she shall furnish at least five such cards  
19 to each polling place in each precinct at the same time and in  
20 the same manner as the printed ballots. The judges or clerks of  
21 election shall post such cards in each voting booth on the day of  
22 election. The card shall contain full instructions on preparing and  
23 casting ballots, including how to cast a write-in vote. The form  
24 and contents of the cards shall be approved by the Secretary of

14 regarding prohibitions on acts of fraud and misrepresentation.

15 Sec. 14. Section 32-915, Revised Statutes Cumulative  
16 Supplement, 2012, is amended to read:

17 32-915 (1) A person whose name does not appear on the  
18 precinct list of registered voters at the polling place for the  
19 precinct in which he or she resides, whose name appears on the  
20 precinct list of registered voters at the polling place for the  
21 precinct in which he or she resides at a different residence  
22 address as described in section 32-914.02, or whose name appears  
23 with a notation that he or she received a ballot for early voting  
24 may vote a provisional ballot if he or she:

25 (a) Claims that he or she is a registered voter who has  
26 continuously resided in the county in which the precinct is located  
27 since registering to vote;

1                   (b) Is not entitled to vote under section 32-914.01 or  
2 32-914.02;

3                   (c) Has not registered to vote or voted in any other  
4 county since registering to vote in the county in which the  
5 precinct is located;

6                   (d) Has appeared to vote at the polling place for the  
7 precinct to which the person would be assigned based on his or her  
8 residence address; and

9                   (e) Completes and signs a registration application before  
10 voting.

11                   (2) A voter whose name appears on the precinct list  
12 of registered voters for the polling place with a notation  
13 that the voter is required to present identification pursuant  
14 to section 32-318.01 but fails to present identification may vote a  
15 provisional ballot if he or she completes and signs a registration  
16 application before voting.

17                   (3) Each person voting by provisional ballot shall  
18 enclose his or her ballot in an envelope marked Provisional  
19 Ballot and shall, by signing the certification on the front of the  
20 envelope or a separate form attached to the envelope, certify to  
21 the following facts:

22                   (a) I am a registered voter in ..... County;

23                   (b) My name or address did not correctly appear on the  
24 precinct list of registered voters;

25                   (c) I registered to vote on or about this date  
26 .....

27                   (d) I registered to vote

1           .... in person at the election office or a voter  
2 registration site,

3           .... by mail,

4           .... by using the Secretary of State's web site,

8           (e) I have not resided outside of this county or voted

14 voted and will not vote in this election except by this ballot.

15           (4) The voter shall sign the certification under penalty  
16 of election falsification. The following statements shall be on  
17 the front of the envelope or on the attached form: By signing the  
18 front of this envelope or the attached form you are certifying to  
19 the information contained on this envelope or the attached form  
20 under penalty of election falsification. Election falsification  
21 is a Class IV felony and may be punished by up to five years  
22 imprisonment, a fine of up to ten thousand dollars, or both.

23           (5) If the person's name does not appear on the precinct  
24 list of registered voters for the polling place and the judge or  
25 clerk of election determines that the person's residence address is  
26 located in another precinct within the same county, the judge or  
27 clerk of election shall direct the person to his or her correct

1 polling place to vote.

2           Sec. 15. Section 32-1002, Revised Statutes Cumulative  
3 Supplement, 2012, is amended to read:

4           32-1002 (1) As the ballots are removed from the ballot  
5 box pursuant to sections 32-1012 to 32-1018, the receiving board  
6 shall separate the envelopes containing the provisional ballots  
7 from the rest of the ballots and deliver them to the election  
8 commissioner or county clerk.

9           (2) Upon receipt of a provisional ballot, the election  
10 commissioner or county clerk shall verify that the certificate on  
11 the front of the envelope or the form attached to the envelope is  
12 in proper form and that the certification has been signed by the  
13 voter.

14           (3) The election commissioner or county clerk shall  
15 also (a) verify that such person has not voted anywhere else  
16 in the county or been issued a ballot for early voting, (b)  
17 investigate whether any credible evidence exists that the person  
18 was properly registered to vote in the county before the deadline  
19 for registration for the election, (c) investigate whether any  
20 information has been received pursuant to section 32-308, 32-309,  
21 32-310, or 32-324 that the person has resided, registered, or voted  
22 in any other county or state since registering to vote in the

25 appropriate changes to the voter registration register by entering
