LB 1073 amends Nebraska Revised Statutes Section 4-114.

The bill changes statute to now require every employer to register with and use a federal immigration verification system to determine work eligibility status of new employees working in the state.

“Employer” is defined to mean all employers subject to the Nebraska Workers’ Compensation Act. In addition, the bill strikes the definitions of “public contractor” and “public employer.”

The Department of Labor is to provide all employers with information regarding the use of the federal immigration verification system.

Any employer violating this requirement is guilty of a Class III misdemeanor.

The bill has an operative date of January 1, 2015.

There is no fiscal impact to the state as a result of LB 1073.
