Explanation of Estimate:

LB 548 changes the length exception for semitrailers transporting baled livestock forage. A semitrailer may exceed the forty-foot limitation but shall not exceed a length of fifty-nine feet six inches including load for purposes of transporting baled livestock forage. This exception shall apply when vehicle is driven to a loading location and then returned to its original location after unloading.

No fiscal impact to the Department is anticipated.
