A BILL

FOR AN ACT relating to abandoned vehicles; to amend section 60-1901,
Reissue Revised Statutes of Nebraska; to provide
procedures for abandoned mobile homes; to define a term;
to harmonize provisions; and to repeal the original section.
Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-1901, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 60-1901 (1) A motor vehicle is an abandoned vehicle:
- 4 (a) If left unattended, with no license plates or valid
- 5 In Transit stickers issued pursuant to the Motor Vehicle Registration
- 6 Act affixed thereto, for more than six hours on any public property;
- 7 (b) If left unattended for more than twenty-four hours on
- 8 any public property, except a portion thereof on which parking is
- 9 legally permitted;
- 10 (c) If left unattended for more than forty-eight hours,
- 11 after the parking of such vehicle has become illegal, if left on a
- 12 portion of any public property on which parking is legally permitted;
- 13 (d) If left unattended for more than seven days on
- 14 private property if left initially without permission of the owner,
- or after permission of the owner is terminated;
- 16 (e) If left for more than thirty days in the custody of a
- 17 law enforcement agency after the agency has sent a letter to the
- 18 last-registered owner under section 60-1903.01; or
- 19 (f) If removed from private property by a municipality
- 20 pursuant to a municipal ordinance.
- 21 (2) An all-terrain vehicle, a utility-type vehicle, or a
- 22 minibike is an abandoned vehicle:
- 23 (a) If left unattended for more than twenty-four hours on
- 24 any public property, except a portion thereof on which parking is
- 25 legally permitted;

1 (b) If left unattended for more than forty-eight hours,

- 2 after the parking of such vehicle has become illegal, if left on a
- 3 portion of any public property on which parking is legally permitted;
- 4 (c) If left unattended for more than seven days on
- 5 private property if left initially without permission of the owner,
- 6 or after permission of the owner is terminated;
- 7 (d) If left for more than thirty days in the custody of a
- 8 law enforcement agency after the agency has sent a letter to the
- 9 last-registered owner under section 60-1903.01; or
- 10 (e) If removed from private property by a municipality
- 11 pursuant to a municipal ordinance.
- 12 <u>(3) A mobile home is an abandoned vehicle if left in</u>
- 13 place on private property for more than thirty days after a local
- 14 governmental unit, pursuant to an ordinance or resolution, has sent a
- 15 <u>certified letter to each of the last-registered owners and posted a</u>
- 16 notice on the mobile home, stating that the mobile home is subject to
- 17 <u>sale or auction or vesting of title as set forth in section 60-1903.</u>
- 18 $\frac{(3)}{(4)}$ For purposes of this section:
- 19 (a) Mobile home means a movable or portable dwelling
- 20 constructed to be towed on its own chassis, connected to utilities,
- 21 and designed with or without a permanent foundation for year-round
- 22 living. It may consist of one or more units that can be telescoped
- 23 when towed and expanded later for additional capacity, or of two or
- 24 more units, separately towable but designed to be joined into one
- 25 integral unit, and shall include a manufactured home as defined in

- 1 section 71-4603. Mobile home does not include a mobile home or
- 2 manufactured home for which an affidavit of affixture has been
- 3 recorded pursuant to section 60-169;
- 4 (a)—(b) Public property means any public right-of-way,
- 5 street, highway, alley, or park or other state, county, or
- 6 municipally owned property; and
- 7 (b) (c) Private property means any privately owned
- 8 property which is not included within the definition of public
- 9 property.
- 10 (4) (5) No motor vehicle subject to forfeiture under
- 11 section 28-431 shall be an abandoned vehicle under this section.
